BY-LAW NO. 3197

A BY-LAW to further amend "BURNABY TOWN PLANNING BY-LAW 1948."

WHEREAS applications have been received by the Municipal Council of The Corporation of the District of Burnaby for certain amendments to the "Burnaby Town Planning By-law 1948":

AND WHEREAS the said applications have been referred to the Burnaby Town Planning Commission for consideration and report:

AND WHEREAS the said Town Planning Commission has reported to the Municipal Council on the applications so referred:

AND WHEREAS the Council of The Corporation of the District of Burnaby, has pursuant to the provisions of Sections 10 and 11 of the "Town Planning Act", held a hearing therein after giving notice of the time and place of such hearing in manner and form provided by the said Act:

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. Schedule 3, "Commercial Zones" of Burnaby Town Planning By-law 1948 is hereby amended by adding thereto the following:

(jj) All that area comprising Lots 10 and 11, of Block 12, of District Lot 122, Group 1. New Westminster District.

2. Schedule 6, "Heavy Industrial Zones" of Burnaby Town Planning By-law 1948 is hereby amended by adding thereto the following:

EAST HEAVY INDUSTRIAL ZONE

Part 3.256 acre portion of Block 10. D.L. 10. Sk.10526.
Lots 2 and 3, Block 1. D.L. 40. Map No. 3048.
Lot 2, Block 2, D.L. 40. Map No. 3048.
Block 13, D.L. 40. Map No. 3048.

CENTRAL HEAVY INDUSTRIAL ZONE

Lot 1 of Block "A" of E.50 acres of West half D.L. 70, Save and except 3 acre part on sketch 8252. Map No. 4328.
Lot 3, Block "A" of E.50 acres of West half D.L. 70. Map 4328.
Block 10, of East 50 acres of West half D.L. 70. Map No. 3216.
Lot "C" of Block 2, D.L. 73. as shewn on Sketch 10599, Save and except South 282 feet. Map 4326.

3. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW 1948 AMENDMENT BY-LAW NO. 3. 1952."
