BY-LAW NO. 3218

A BY-LAW to amend the "Burnaby Town Planning By-law 1948".

WHEREAS applications have been received by the Municipal Council of The Corporation of the District of Burnaby for certain amendments to the "Burnaby Town Planning By-law 1948".

AND WHEREAS the said applications have been referred to the Burnaby Town Planning Commission for report.

AND WHEREAS the said Town Planning Commission has recommended to the Council that the undermentioned amendments to the By-law be made.

AND WHEREAS the Council of The Corporation of the District of Burnaby, has, pursuant to the provisions of Sections 10 and 11 of the Town Planning Act, held a hearing therein, after giving notice of the time and place of such hearing in manner and form provided by the said Act.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. That Schedule set forth in the Burnaby Town Planning By-law 1948 shall be amended as follows:

SCHEDULE 6

HEAVY INDUSTRIAL ZONE

NORTH HEAVY INDUSTRIAL ZONE

Shall be and is hereby amended by striking out the words

"On the south, McGill Street from the above mentioned Block line to Madison Avenue; Madison Avenue to Yale Street; Yale to Carleton Avenue; Carleton to Edinburgh Street; Edinburgh to Gilmore Avenue.

and by substituting therefor the following:  
"On the south, McGill Street from the above mentioned Block line to Madison Avenue; Madison Avenue to Trinity Street; Trinity Street to West boundary of Lot 27,

Block 32, D.L. 187; West boundary of Lot 27, Block 32, D.L. 187 to South Boundary of Lot "C", D.L. 187; South boundary of Lot "C", D.L. 187 to East boundary of Lot 7, Block 32, D.L. 187; East boundary of Lot 7 Block 32, D.L. 187 to Yale Street; Yale Street to Carleton Avenue; Carleton Avenue to Edinburgh Street; Edinburgh Street to Gilmore Avenue.

2. This By-law may be cited as "BURNABY TOWN  
PLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 5, 1952."
