BY-LAW NO. 3222

A BY-LAW to authorize the sale of certain

Tax Sale Lands belonging to The

Corporation of the District of

Burnaby, and to accept in part or

full payment therefor, other lands
in the Municipality.

WHEREAS The Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lots One (1) and Thirty (30) of Block Thirty-six (36) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046.

AND WHEREAS Malcolm McKellar and Delores McKellar, of the Municipality of Burnaby, Province of British Columbia, are the owners of lands and premises described as Lot "A" of Block "D" of part of Block "A" of the Centre portion of District Lot Twenty-eight (28), Group One (1), New Westminster District, Map No. 10412.

AND WHEREAS the said Malcolm McKellar and Delores McKellar have requested the Corporation to convey to them the said lands described Lots One (1) and Thirty (30) of Block Thirty-six (36) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046 and to accept in full payment therefor conveyance of the said Lot "A" of Block "D" of part of Block "A" of the Centre portion of District Lot Twenty-eight (28), Group One (1), New Westminster District, Map No. 10412.

AND WHEREAS it is deemed advisable to effect such exchange.

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

l. Upon the execution and delivery to The Corporation of the District of Burnaby by Malcolm McKellar and Delores

McKellar of a good and sufficient deed of the lands and premises described as Lot "A" of Block "D" of part of Block "A" of the Centre portion of District Lot Twenty-eight (28), Group One (1), New Westminster District, Map No. 10412, free and clear of all encumbrance whatsoever, the Reeve and the Clerk are hereby authorized and empowered to execute and set the official and Corporate Seal of The Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lots One (1) and Thirty (30) of Block Thirty-six (36) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046 to the said Malcolm McKellar and Delores McKellar, and to deliver such Conveyance when so executed to the said Malcolm McKellar and Delores McKellar.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 2, 1952".
