THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3245

A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to The Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS The Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lot Nine (9) of Sub-division of Lot Ten (10) of Block Two (2) of District Lot Twenty-five (25), Group One (1), New Westminster District, Map No. 2338.

AND WHEREAS The Toronto General Trusts Corporation and George Russell Walker "In Trust", are the owners of lands and premises described as the East Half of Lot Four (4) of Block Thirty-nine (39) of District Lot Sixty-nine (69), Group One (1), New Westminster District, Map No. 1321.

AND WHEREAS The Toronto General Trusts Corporation and George Russell Walker "In Trust", have requested the Corporation to convey to them the said lands described as Lot Nine (9) of Sub-division of Lot Ten (10) of Block Two (2) of District Lot Twenty-five (25), Group One (1), New Westminster District, Map No. 2338 and to accept in full payment therefor conveyance of the said East Half of Lot Four (4) of Block Thirty-nine (39) of District Lot Sixty-nine (69), Group One (1), New Westminster District, Map No. 1321.

AND WHEREAS it is deemed advisable to effect such exchange.

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. Upon the execution and delivery to The Corporation of the District of Burnaby by The Toronto General Trusts Corporation and George Russell Walker "In Trust", of a good and sufficient deed of the lands and premises described as the East Half of Lot Four (4) of Block Thirty-nine (39) of District Lot Sixty-nine (69), Group One (1), New Westminster District, Map No. 1321, free and clear of

all encumbrance whatsoever, the Reeve and the Clerk are hereby authorized and empowered to execute and set the official and Corporate Seal of The Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lot Nine (9) of Sub-division of Lot Ten (10) of Block Two (2) of District Lot Twenty-five (25), Group One (1), New Westminster District, Map No. 2338 to The Toronto General Trusts Corporation and George Russell Walker "In Trust", and to deliver such Conveyance when so executed to The Toronto General Trusts Corporation and George Russell Walker "In Trust".

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 3, 1952".
