BY-LAW NO. 3277

A BY-LAW to authorize the sale of Lot "M", Block 19, District Lot 27, Group 1, New Westminster District, Sketch No. 12861, to Robert Gordon Quennell.

WHEREAS land and premises described as Lots Fifty-two (52) Save and Except the Easterly 16% feet thereof, and Fifty-three (53), Block Nineteen (19) of subdivision of District Lot Twenty-seven (27), Group One (1), New Westminster District, Province of British Columbia, was acquired by the Corporation of the District of Burnaby in the year 1929 for Corporate purposes.

AND WHEREAS the Corporation did in the year 1952 effect a consolidation of the said property which is now described as Lot "M", Block Nineteen (19), District Lot Twenty-nine (29), Group One (1), New Westminster District, Province of British Columbia, Sketch No. 12861.

AND WHEREAS the said lands and premises are no longer required for Corporate purposes.

AND WHEREAS under the provisions of Section 43 of the "District of Burnaby Debt Refunding Act, 1940" permission has been received from the Minister of Municipal Affairs for the Corporation to dispose of the said lot for the sum of \$1,050.00.

AND WHEREAS Robert Gordon Quennell, of 323 Regina Street, in the City of New Westminster, Province of British Columbia, has offered to purchase the said property for the sum of \$1,050.00.

AND WHEREAS it is deemed expedient to accept the said offer.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. That Lot "M" of Block Nineteen (19) of District
 Lot Twenty-seven (27), Group One (1), New Westminster
 District, Sketch No. 12861, be sold and disposed of to
 Robert Gordon Quennell, of 323 Regina Street, in the City
 of New Westminster, Province of British Columbia, for the
 sum of One thousand, and Fifty (\$1,050.00) dollars, and that
 upon payment of the said sum to The Corporation of the
 District of Burnaby that the Reeve and Clerk be authorized
 to execute and set the Corporate Seal of the Corporation to
 an Indenture of Conveyence to the said Robert Gordon Quennell.
- 2. This By-law shall take effect upon the registration thereof.
- 3. This By-law may be cited for all purposes as "BURNABY CORPORATE LAND SALE BY-LAW NO. 1, 1953".
