

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3294

A BY-LAW to amend By-law No. 3127 of the Corporation.

WHEREAS the Council of The Corporation of the District of Burnaby did by By-law No. 3127 grant an easement to the British Columbia Electric Company Limited through and over certain lands included in Right-of-Way Plan No. 12169, deposited in the Land Registry Office at New Westminster, Province of British Columbia.

AND WHEREAS the said Right-of-Way Plan has been amended by deposit by the said Company of Right-of-Way Plan No. 13332 in the said Land Registry Office.

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. It shall be lawful for the Reeve and Clerk of The Corporation of the District of Burnaby to sign and affix the Corporate Seal of the Corporation to an Indenture of Agreement in the form attached to and forming part of this By-law, all as an act and deed of The Corporation of the District of Burnaby, and to deliver same to the British Columbia Electric Company Limited.

2. This By-law may be cited as "BRITISH COLUMBIA ELECTRIC COMPANY LIMITED EASEMENT AUTHORIZATION BY-LAW 1951, AMENDMENT BY-LAW 1953".
