Shall be and is hereby emended by deleting item No. (25), and substituting therefor the following as item No. (25):

(25) All that area on the north west corner of Barnet Road and Pandora Street comprised of the St of Lot 1, and Lot 35, Block 2, District Lot 216, Plan No. 11555.

SCHEDULE 7

GASOLINE SERVICE STATION ZONE

Shall be and is hereby amended by adding thereto the following as Paragraph (k):

(k) Ni of Lot 1, Block 2, District Lot 216, Sketch No. 12927.

This By-law may be cited as "BURNABY TOWN PLANNING 2. BY-LAW 1948 AMENDMENT BY-LAW NO. 6, 1953".
