



THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3426

A BY-LAW for fixing hours for closing of Barber Shops in the District of Burnaby.



WHEREAS by Section (4) of the "Shops Regulation and Weekly Holiday Act", R.S.B.C. 1948, it is provided that any municipal Council may, by by-law, require that during the whole or any part or parts of the year all or any class or classes of shops within the municipality shall be closed and remain closed on each and any day of the week at and continuously after or for the time and hour fixed or appointed in that behalf by the by-law, as follows:

(a) On any statutory legal holiday, for the whole or any part of such day.

(b) On any one or more half-holidays in any one week, made such by a municipal by-law, the hour for closing shall not be earlier than twelve o'clock noon of such day.

(c) On any other day of the week the hour fixed or appointed by the by-law for closing shall not be earlier than five of the clock in the afternoon; and the by-law shall be subject in all respects to the provisions of Part II of the said Act.

AND WHEREAS pursuant to Section 5 of the "Shops Regulation and Weekly Holiday Act", a petition has been submitted to the Municipal Council signed by more than one-half in number of the licensed occupiers of barber shops situate within the Municipality praying that By-law No. 1491 as amended by By-laws numbered 1697 and 1919, be repealed.

AND WHEREAS pursuant to Section (5) of the "Shops Regulation and Weekly Holiday Act", an application has been presented to the Municipal Council signed by not less than three-fourths in number of the licensed occupiers of barber

shops situate within the Municipality of the District of Burnaby under Municipal licences issued in respect of those shops praying for the passing of a by-law requiring the closing of all barber shops situate within the said Municipality at the time and hours mentioned in that behalf in the application and hereinafter set forth in this By-law.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. In this By-law, unless the context otherwise requires,

"Barbering" means the engaging in the shaving of the face or cutting or trimming or singeing of the hair or beard for hire, gain or hope of reward, or in connection with any of the foregoing the shampooing or massaging or the treating the head or face, or in respect of any of the aforesaid the charging for any material used in connection therewith.

"Barber Shop" means any place, room, premises, building or part thereof where the occupation of barbering is carried on.

2. On Tuesday, Wednesday, Thursday and Friday of each and every week, all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed from and after the hour of 6 o'clock in the afternoon until the hour of 8 o'clock in the forenoon of the following day.

3. On Saturday of each and every week all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed from and after the hour of 6 o'clock in the afternoon until the hour of 8 o'clock in the forenoon of the Tuesday next following.

4. Save as hereinafter mentioned, on Monday of each and every week, all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed during the whole of the day. PROVIDED that the provisions of this section shall not apply in respect of any of the seven days immediately preceding Christmas Day in any year.

5. On all Statutory legal holidays, all barber shops within the said Municipality shall be closed and remain closed for the whole of such days.

6. On the days next previous to the aforesaid statutory legal holidays, the hour of closing shall not be later than 6 o'clock in the afternoon.

7. All barber shops shall be closed and remain closed each Sunday during the whole of the day.

8. Every owner, occupier or manager of any barber shop who allows, suffers or permits such barber shop to remain open during any of the times prohibited by this By-law shall be liable upon summary conviction for each offence, to a fine not exceeding Fifty dollars (\$50.00) and costs.

9. This By-law shall take effect upon the date of registration thereof.

10. The following By-laws are hereby repealed:

11. This By-law may be cited as "BARBER SHOPS REGULATION BY-LAW 1954".
