THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3429

A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to The Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale Proceedings, lands and premises described as Lot Ten (10) of Block Twenty-four (24), of Lot Two Hundred and eight (208), Group One (1), New Westminster District, Map 2501.

AND WHEREAS Rosenthal Charles and Leah Charles are the owners of lands and premises described as North half $(N_{\overline{2}}^1)$ of Lot Six (6) and South half $(S_{\overline{2}}^1)$ of Lot Seven (7) of Block Ten (10) of Lot Two Hundred and Eight (208), Group One (1), New Westminster District, Map 2501.

AND WHEREAS Rosenthal Charles and Leah Charles have requested the Corporation to convey to them the said lands described as Lot Ten (10) of Block Twenty-four (24), of Lot Two Hundred and eight (208), Group One (1), New Westminster District, Map 2501, and to accept in full payment therefor conveyance of the said North half $(N_{\overline{E}}^1)$ of Lot Six (6) and South half $(S_{\overline{E}}^1)$ of Lot Seven (7) of Elock Ten (10) of Lot Two Hundred and Eight (208), Group One (1), New Westminster District, Map 2501.

AND WHEREAS it is deemed advisable to effect such ex-

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows: -

1. Upon the execution and delivery to The Corporation of the District of Burnaby by Rosenthal Charles and Leah Charles of a good and sufficient deed of lands and premises described as the North half $(N_{\overline{2}})$ of Lot Six (6) and South half $(\overline{S_2})$ of Lot Seven (7) of Block Ten (10) of Lot Two Hundred and Eight (208), Group One (1), New Westminster District, Map 2501, free and clear of all encumbrance whatsoever, the Reeve and Clerk are hereby authorized and empowered to

execute and set the official and Corporate Seal of The Corporation of the District of Burnaby to a conveyance of lands and premises described as Lot Ten (10) of Block Twenty-four (24) of Lot Two Hundred and eight (208), Group One (1), New Westminster District, Map 2501, to Rosenthal Charles and Leah Charles, and to deliver such Conveyance when so executed to the said Hosenthal Charles and Leah Charles.

2. This by-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 1, 1954."
