THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3438

A BY-LAW to declare the desirability of undertaking certain works as local improvements under the provisions of the Local Improvement Act.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. That it is hereby declared that it is desirable to construct combined storm and sanitary sewers as local improvements in the streets and between the points set out in the proposed Notice of Intention, being Schedule "A" to this By-law.

2. That notice of this Council's intention to undertake the said work in the form annexed to this ^By-law be published as required by the Local Improvement Act.

3. This By-law may be cited as "BURNABY LOCAL IMPROVEMENT NOTICE OF INTENTION BY-LAW NO. 2, 1954(Sewers)".

Thence in the same direction along the southern boundary of Lot 7, Block 17, D.L. 29, Plan 11015, to the south west corner of said lot.
