

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3439

A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to The Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS The Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lots Four (4) to Ten (10) inclusive, of Block Forty nine (49), of District Lot One hundred and twenty three (123), Group One (1), Map 1543, New Westminster District.

AND WHEREAS the C. B. Riley Construction Co. Ltd. are the owners of lands and premises described as Lots Eleven (11) to Seventeen (17) inclusive, of Block Forty (40) of District Lot One hundred and twenty three (123), Group One (1), Map 1543, New Westminster, B.C.

AND WHEREAS the C. B. Riley Construction Co. Ltd. have requested the Corporation to convey to them the said lands described as Lots Four (4) to Ten (10) inclusive, of Block Forty nine (49), of District Lot One hundred and twenty-three (123), Group One (1), Map 1543, New Westminster District, and to accept in full payment therefor conveyance of the said Lots Eleven (11) to Seventeen (17) inclusive, of Block Forty (40) of District Lot One hundred and twenty three (123), Group One (1), Map 1543, New Westminster, B.C.

AND WHEREAS it is deemed advisable to effect such exchange.

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. Upon the execution and delivery to The Corporation of the District of Burnaby by C. B. Riley Construction Co. Ltd. of a good and sufficient deed of lands and premises described as Lots Eleven (11) to Seventeen (17) inclusive, of Block Forty (40) of District Lot One hundred and twenty three (123), Group One (1), Map 1543, New Westminster District, free and clear of all encumbrances whatsoever, the Reeve and Clerk are hereby authorized and empowered to execute and set the official and Corporate Seal of

The Corporation of the District of Burnaby to a conveyance of lands and premises described as Lot Four (4) to Ten (10) inclusive, of Block Forty nine (49), of District Lot One hundred and twenty three (123), Group One (1), Map 1543, New Westminster District, to C. B. Riley Construction Co. Ltd., and to deliver such Conveyance when so executed to the said C. B. Riley Construction Co.Ltd.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 3, 1954".

DONE AND PASSED by a Three-fourths vote of the Council on the Twenty-second (22nd) day of March, A. D. 1954.
