

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3474

A BY-LAW to amend the "Burnaby Town Planning By-law 1948."

WHEREAS applications have been received by the Municipal Council of The Corporation of the District of Burnaby for certain amendments to the "Burnaby Town Planning By-law 1948."

AND WHEREAS the said applications have been referred to the Burnaby Town Planning Commission for report.

AND WHEREAS the Council of The Corporation of the District of Burnaby has, pursuant to the provisions of Sections 10 and 11 of the "Town Planning Act" held a Hearing therein, after giving notice of the time and place of such Hearing in manner and form provided by the said Act.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. That the Schedules set forth in the Burnaby Town Planning By-law 1948, being By-law No. 1991 shall be amended as follows:-

SCHEDULE 6 - HEAVY INDUSTRIAL ZONE

Shall be and is hereby amended by adding thereto the following:

Central Heavy Industrial Zone

All that area bounded on the north by Cypress Street, on the south by Clydesdale Street, on the east by Sumner Avenue and on the west by Gilmore Avenue.

All the area bounded on the north by Clydesdale Street, on the south by Norfolk Street, on the east by Sumner Avenue and on the west by Crown Avenue.

All that area bounded by Winston Street, the north boundaries of Lots 19 and the north half of Lot 26, Blocks 1, 2, and 3, D.L. 43, Plan 3327, Phillips Avenue, Government Street, and the Vancouver-Victoria and Eastern Railway right-of-way.

SCHEDULE 7 - GASOLINE SERVICE STATION ZONES

Shall be and are hereby amended by adding thereto the following as paragraphs (p) and (q):

(p) All that area comprised of Lot 14, save and except the east 14', 15 and 16, Blocks 68, D.L. 34, Plan 2801 (located at the south-west corner of Moscrop Street and Willingdon Avenue.

2. This By-law may be cited for all purposes as "BURNABY TOWN PLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 3, 1954".

DONE AND PASSED by a three-fourths majority of the Municipal Council, this Seventh (7th) day of June, A.D. 1954.
