THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3478

A BY-LAW to authorize the construction of pavements and other works as local improvements under the provisions of the "Local Improvement Act".

WHEREAS separate petitions have been received by the Municipal Council to construct as local improvements the respective works hereinafter described and the Clerk has certified that the respective petitions are sufficient, and it is expedient to grant the prayer of such petitions in manner hereinafter provided;

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:-

- 1. The following works shall be constructed as local improvements under the provisions of the "Local Improvement Act".
- A. That an Asphalt pavement 20 feet wide be constructed on Carson Street from Sussex Avenue to Strathearn
 Avenue.
- B. That an Asphalt pavement 20 feet wide be constructed on Clinton Street from Hedley Avenue to the West Property Line Lot 1, D.L. 160, Plan 11554, and Lot 18, D.L. 160, Plan 11041.
- C. That an Asphalt pavement 20 feet wide be constructed on McKee Street from Buller Avenue to Gilley Avenue.
- D. That an Asphalt pavement 20 feet wide be constructed on Bryant Street from Gilley Avenue to the road east of Gilley Avenue.
- E. That an Asphalt pavement 20 feet wide be constructed on Dent Street from Kitchener Street to Graveley Street.
- F. That an Asphalt pavement 20 feet wide be constructed on Arbor Street from Boundary Road to Joffre Avenue.

- G. That an Asphalt pavement 20 feet wide be constructed on Parker Street from Willingdon Avenue to Alpha Avenue.
- H. That an Asphalt pavement 20 feet wide be constructed on Napier Street from Alpha Avenue to Beta Avenue.
- I. That an Asphalt pavement 20 feet wide be constructed on Napier Street from Willingdon Avenue to Alpha Avenue.
- J.That an Asphalt pavement 20 feet wide be constructed on Victory Street from Boundary Road to Joffre Avenue.
- 2. The Engineer of the Corporation do forthwith make such plans, profiles, and specifications and furnish such improvement as may be necessary for the making of a contract for the execution of the work.
- The work shallbe carried on and executed under the superintendence and according to the directions and orders of such Engineer.
- 4. The Reeve and Clerk are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to the approval of this Council to be declared by resolution
- The Treasurer may (subject to the approval of the Council) agree with any bank or person for temporary advances of money to meet the cost of the work pending the completion of it.
- 6. The special assessment shall be paid by two annual instalments.
- The debentures to be issued for the loan to be effected to pay for the cost of the work when completed shall bear interest at four (4%) per centum per annum, and be made payable within two years on the serial plan.

- Any person whose lot is specially assessed may commute for a payment in cash the special rates imposed thereon, by paying the portion of the cost of construction assessed upon such lot, without the interest, forthwith after the special assessment roll has been certified by the Clerk.
- 9. This By-law may be cited as "BURNABY LOCAL IMPROVEMENT CONSTRUCTION BY-LAW NO. 12, 1954".
