THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3515

A BY-LAW to amend the Burnaby Street and Traffic By-law 1954 being By-law No. 3477 of The Corporation of the District of Burnaby.

THE MUNICIPAL COUNCIL of The Corporation of the District of Burnaby ENACTS as follows:

1. Section 122 of By-law No. 3477 is repealed and the following is substituted:

"122. Every person who violates any provision of this By-law shall be guilty of an offense and shall upon conviction thereof before a police magistrate or one or more justices of the peace or other magistrate or magistrates having jurisdiction in the Municipality of Burnaby on the oath or affirmation of any credible witness forfeit and pay at the discretion of the said police magistrate, justice or justices of the peace or other magistrate or magistrates convicting, a pecuniary penalty not exceeding the sum of Two Hundred and Fifty Dollars (\$250.00) together with a sum for costs or without costs; and that

(a). In default of payment forthwith, or within such limited time as the police magistrate or one or more justices of the peace or other magistrate or magistrates may allow, of such pecuniary penalty and costs if the conviction or order is made with costs, it shall be lawful for such police magistrate, justice or justices or other magistrate or magistrates convicting as aforesaid by a warrant under his hand and seal or in case two or more justices act together therein then under the hand and seal of any one of them to cause the said pecuniary penalty or penalty and costs or costs only if not paid forthwith or within such limited time as aforesaid to be levied by distress and sale of the goods and chattels of the defendant and if sufficient distress cannot be found to cause the defendant

to be imprisoned for a term of thirty (30) days or some part thereof as directed by the said police magistrate or justice or justices or other magistrate or magistrates convicting as aforesaid in the common gaol of the County of Westminster at Oakalla in the Municipality of Burnaby in the Province of British Columbia, unless the pecuniary penalty imposed and costs if the conviction or order is made with costs, and the costs and charges of the distress and of the commitment and of the conveying of the defendant to gaol are sooner paid; or

(b). In default of payment of such pecuniary penalty and costs (if any) or penalty or costs only imposed forthwith or within such limited time as the police magistrate or one or more justices of the peace or other magistrate or magistrates may allow, it shall be lawful for the police magistrate, justice or justices or other magistrate or magistrates convicting as aforesaid to commit the offender to the common gaol of the County of Westminster at Oakalla in the Municipality of Burnaby in the Province of British Columbia, or the nearest lockup house for a term of thirty (30) days or some part thereof unless the said several sums, the costs and charges of the commitment and of the conveying of the said offender to the common gaol are sooner paid."

2. SCHEDULE "A" of Subsection (a) of Section 19 of By-law 3477 is amended by adding thereto the following:

"Edmonds Street	-	Kingsway to 19th Street"
"Rumble Street	-	Gilley Avenue to 21st Avenue"
"21st Avenue	-	Rumble Street to 19th Street"
"19th Street	-	21st Avenue to Stride Avenue"
"Oxford Street	-	Boundary Road to Willingdon Avenue except Gilmore Avenue and Willingdon Avenue."

3. SCHEDULE "A" of Subsection (a) of Section 19 of By-law 3477 is further amended by adding after "except" in the second line of the paragraph headed "Willingdon Avenue" the words "Oxford Street".

4. SCHEDULE "A" of Subsection (a) of Section 19 of By-law 3477 is further amended by adding after "for" in the second line of the paragraph headed "Gilmore Avenue" the words " Oxford Street ".

5. This By-law shall come into force and take effect on and after the date of registration thereof.

6. This By-law may be cited as the "BURNABY STREET AND TRAFFIC BY-LAW 1954, AMENDMENT BY-LAW NO. 3, 1954".
