THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3541

A BY-LAW to define and set aside certain lands within the Municipality of Burnaby for Park purposes.

WHEREAS by paragraph (d) of sub-section 202 of Section 58 of the "Municipal Act" R.S.B.C. 1948 it is provided that in every municipality the Council may, by By-law, finally passed by a three-fourths vote of all the members thereof, and without obtaining the assent of the electors, define an area comprising lands that have become the property of the Municipality through tax sale proceedings and set aside such area for park purposes, for recreation grounds, or school sites, or other public purposes.

AND WHEREAS the undermentioned lands have become the property of the Municipality through tax sale proceedings.

AND WHEREAS it is deemed expedient and in the public interest that the said hereinafter mentioned lands in the Municipality of Burnaby should be set aside for Parks purposes.

THEREFORE THE MUNICIPAL COUNCIL of The Corporation of the District of Burnaby ENACTS as follows:

- l. There is hereby defined and set apart for park purposes all of the undermentioned lands, viz:
 - (a) Lot "C", Blocks Three (3) and Four (4),
 District Lot Thirty (30), Group One (1),
 New Westminster District, Plan 12944.
 - (b) Lots Eleven (11) to Seventeen (17), Block Six (6), District Lot Sixty-eight (68), Group One (1), New Westminster District, Plan 980.

- (c) Lot "E", Block Seven (7) of Lot "C" of
 Parcel "A", District Lot Sixty-eight (68),
 Group One (1), New Westminster District,
 Plan 14962.
- (d) Lot One (1), Blocks One (1) and Two (2),
 District Lot Forty-two (42), Group One (1),
 New Westminster District, Plan 3647.
- (e) Lots One (1) to Four (4) and Fourteen (14) to Twenty-eight (28), Block One (1), of Block "E", District Lot One hundred and eighty-eight (188), Group One (1), New Westminster District, Plan 1165.
- (f) Lots One (1) to Nineteen (19), Block Four (4), of Block "E", District Lot One hundred and eighty-eight (188), Group One (1), New Westminster District, Plan 1165. Block "E"
- (g) Block Five (5), District Lot One hundred and eighty-eight (188), Group One (1), New Westminster District, Plan 1165.
- (h) Lot "D", Block Eight (8), of Block "E", District Lot One hundred and eighty-eight (188), Group One (1), New Westminster District, Plan 14937.
- (i) Block One hundred and four (104), Parcel "G", District Lot One hundred and twenty-three (123), Group One (1), New Westminster District, Plan 15025.
- 2. This By-law may be cited as "BURNABY PARK DEDICATION BY-LAW 1955".
