

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3562

A BY-LAW to amend "Burnaby Town Planning By-law 1948," being By-law No. 1991 of the Corporation.

WHEREAS applications have been received by the Municipal Council for amendments to "Burnaby Town Planning By-law 1948".

AND WHEREAS the Municipal Council has approved the said applications for further consideration, and has held a Public Hearing, pursuant to the provisions of Sections 10 and 11 of the "Town Planning Act", after giving notice of the time and place of such Hearing in manner and form provided by the said Act.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. That the Schedules set forth in "Burnaby Town Planning By-law 1948", being By-law No. 1991 of the Corporation, shall be amended as follows:-

SCHEDULE 4 - LOCAL COMMERCIAL ZONES

Shall be and is hereby amended by adding thereto the following as Paragraphs (29) and (30):-

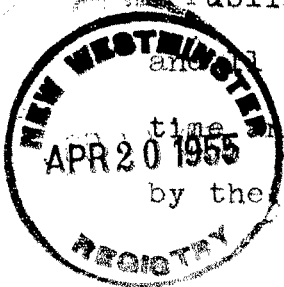
- (29) All that area comprised of Lots 7C and 8C, Subdivision 7, Block 5, D.L. 74, Plan 1852, save and except the Easterly 7 feet thereof.
- (30) All that area comprised of Lots 16 to 19 inclusive, Block 7, D.L. 70W. $\frac{1}{2}$ of E. $\frac{1}{2}$, Plan 1397.

SCHEDULE 5 - LIGHT INDUSTRIAL ZONE

South Area

Shall be and is hereby amended by adding thereto the following:-

All that area comprised of Lots 16 to 23 inclusive, Lot "A" (Plan 4765), and Lots 26 to 32 inclusive, Subdivision 50, Block 2, District Lot 95, Plan 2073, Save and Except the Easterly 64 feet abutting 19th Street and Save and Except the Southerly 60 feet abutting 16th Avenue.



SCHEDULE 6 - HEAVY INDUSTRIAL ZONES

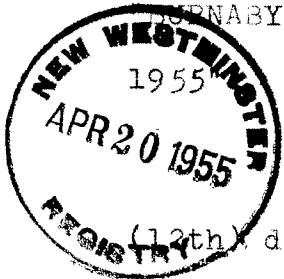
CENTRAL HEAVY INDUSTRIAL ZONE

The second paragraph under "Central Heavy Industrial Zone", as enacted by By-law No. 3281 of the Corporation, shall be and is hereby amended by deleting the words "and on the east by Westminster Avenue" and by substituting therefor the words "and on the east by the East boundary of Lot "C", Except Explanatory Plan 10599, Block 2, District Lot 73, Plan 4326.

Said Central Heavy Industrial Zone shall be and is hereby further amended by adding the words "All that area comprised of Lot "C", Explanatory Plan 10599, Block 2, District Lot 73, Plan 4326, Save and Except the South 50 feet abutting on Grandview Highway, and Save and Except the East 50 feet abutting on Westminster Avenue.

2. This By-law may be cited for all purposes as
