A BY-LAW to amend By-law No. 3089, being the "Burnaby Trades License By-law 1950"

THE MUNTCIPAL COUNCIL of The Corporation of the District of Burnaby in Open Meeting assembled, ENACTS as follows:-

1. The definition of "Laundry" as it appears in Section 1 is struck out and the following substituted therefor: "'Laundry' means any building or part thereof where the business of pressing, cleaning, dying or the washing of clothing or other fabrics is carried on, and shall include premises where the business of linen supply is carried on."
2. The definition of "Manufacturer" as it appears in Section 1 is amended by striking out all the words after "wood fabricating plant".
3. SECTION 27 of Schedule "A" is repealed.
4. SECTION 74 of Schedile "A" is repealed and the following substituted therefor:
"74. MACHINE SHOPS.
Every person carrying on the business of a machine shop shall, every six months, pay a license fee as follows:
(a) If one (1) to five (5) persons are engaged in the business, the sum of Ten (\$10.00) Dollars,
(b) If six (6) to ten (10) persons are engaged in the business, the sum of Twenty ( $\$ 20.00$ ) Dollars,
(c) If eleven (11) to twenty-five (25) persons are engaged in the business, the sum of Fifty ( $\mathrm{W}_{\mathrm{W}} 50.00$ ) Dollars,
(d) If over twenty-five (25) persons are engaged in the business, the sum of One hundred (\$100.00) Dollars."
5. SECTION 76 of Schedule "A" is repealed and the following substituted therefor:
"76. MANUFACTURER.
Every person carrying on the business of a manufacturer shall, every six months, pay a license fee as follows:
(a) If one (1) to five (5) persons are engaged in the business, the sum of Ten (\$10.00) Dollars,
(b) If $\operatorname{six}(6)$ to ten (10) persons are engeged in the business, the sum of Twenty (20.00) Dollers,
(c) If eleven (11) to twenty-five (25) persons are engaged In the business, the sum of Fifty (\$0.00) Dollars,
(d) If over twenty-five (25) ipersons are engaged in the business, the sum of One hundred (\$100.00) Dollars."
6. SECTION 119 of Schedule "A" is repealed and the following substituted therefor:
"119. STEEL FABRICATING PLANTS.
Every person carrying on the business of steel and/or iron fabricating shall, every six months, pay a license fee as follows:
(a) If one (1) to five (5) persons are engaged in the business, the sum of Ten (tho.00) Dollars,
(b) If six (6) to ten (10) persons are engaged in the business, the sum of Twenty (\$20.00) Dollers,
(c) If eleven (11) to twenty-five (25) persons are engaged in the business, the sum of Fifty (50.00) Dollars,
(d) If over twenty-five (25) persons are engaged in the business, the sum of one hundred ( $\$ 100.00$ ) Dollars."
7. SECTION 146 of Schedule "A" is repealed and the following substituted therefor:
"I46. WOODWORKING SHOPS.
Every person carrying on the business of a woodworking shop shall, every six months, pay a license fee as follows:
(a) If one (1) to five (5) persons are engaged in the business, the sum of Ten (\$10.00) Dollars,
(b) If six (6) to ten (10) persons are engaged in the business, the sum of Twenty ( 420.00 ) Dollars,
(c) If eleven (11) to twenty-five (25) persons are engeged in the business, the sum of Fifty ( $\$ 50.00$ ) Dollars,
(d) If over twenty-five (25) persons are engaged in the business, the sum of One hundred ( ${ }^{6} 100.00$ ) Dollars."
8. SECTION 147 of Schedule "A" is repealed and the following substituted therefor:
"147. WOOD FABRICATING PIANTS.
Every person carrying on the business of a Wood fabricating plent shall, every six months, pay a license fee as follows:
(a) If one (1) to five (5) persons are engaged in the business, the sum of Ten (\$10.00) Dollars,
(b) If six (6) to ten (10) persons are engaged in the business, the sum of Twenty (\$20.00) Dollars,
(c) If eleven (11) to twenty-five (25) persons are engaged in the business, the sum of Fifty ( 40.00 ) Dollers,
(a) If over twenty-five (25) persons are engaged in the business, the sum of One hundred ( 4100.00 ) Dollers."
9. This By-law shall come into force and take effect upon registration thereof.
10. This By-law may be cited for all purposes as the "BURNABY TRADES LICENSE BY-LAW 1950, AMENDMENT BY-LAW NO. 2, 1955*.
