

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3604

A BY-LAW to authorize the granting of a lease
of certain municipally-owned lands
to The Royal Bank of Canada.

THE MUNICIPAL COUNCIL of The Corporation of the
District of Burnaby in open meeting assembled ENACTS as
follows:

1. The Municipal Council of The Corporation of the
District of Burnaby is hereby authorized and empowered
to demise and lease unto The Royal Bank of Canada those
municipally-owned lands situate, lying and being in the
Municipality of Burnaby, in the Province of British
Columbia and more particularly known and described as
Lot Four (4) of the northerly portion of Block Fourteen
(14) of District Lot One hundred and fifty-three (153),
Group One (1), New Westminster District, Map 2236 SAVE
AND EXCEPT part subdivided by Map 5072, AND portion of Lot
Five (5) of the northerly portion of Block Fourteen (14)
of District Lot One hundred and fifty-three (153), Group
One (1), New Westminster District, Map 2236 for the term
of ten (10) years commencing on the First (1st) day of
July, 1955 and ending on the Thirtieth (30th) day of June,
1965 yielding and paying therefor the clear annual rent or
sum of Four Hundred (\$400) Dollars and otherwise upon the
terms, covenants and conditions contained in a certain
indenture of lease of the said lands and premises made
between The Corporation of the District of Burnaby as
lessor and The Royal Bank of Canada as lessee and dated
the Twenty-fifth (25th) day of July, 1955.

2. The Reeve and Clark are hereby authorized and em-
powered to sign the said indenture of lease on behalf of

The Corporation of the District of Burnaby and to affix the corporate seal thereto.

3. This By-law shall take effect and come into force upon registration thereof.

4. This By-law may be cited as "THE ROYAL BANK OF CANADA LEASE AUTHORIZATION BY-LAW 1955".

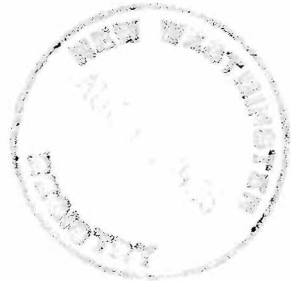
