

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3619

A BY-LAW to dedicate a portion of certain municipally owned lands for highway purposes.

WHEREAS the Corporation is the owner in fee simple of those lands situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and more particularly known and described as Blocks Eight (8) and Nine (9), of Lot Seventy-nine (79), Group One (1), New Westminster District, according to Plan 536 deposited in the Land Registry Office, in the City of New Westminster, Province of British Columbia.

AND WHEREAS it is deemed expedient and in the public interest to dedicate that portion of the said lands hereinafter described for highway purposes.

THEREFORE, THE MUNICIPAL COUNCIL of The Corporation of the District of Burnaby ENACTS as follows:

1. That the hereinafter described portion of Blocks Eight (8) and Nine (9), of Lot Seventy-nine (79), Group One (1), New Westminster District, Plan 536 be and the same is hereby dedicated as a highway to and for the free use of the public in all time hereafter.

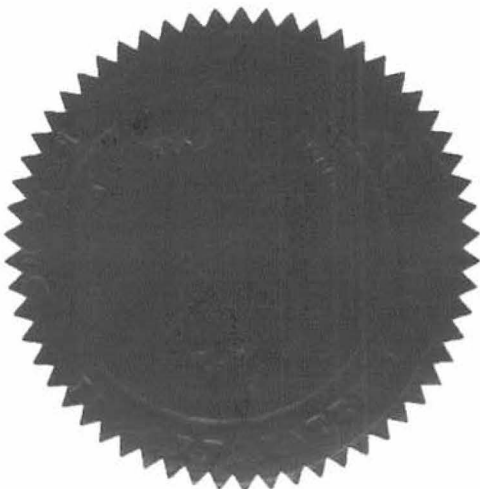
COMMENCING at the north-west corner of Block Nine (9) of Lot Seventy-nine (79), Group One (1), New Westminster District, Plan 536, thence South two degrees nineteen minutes East (S.2°19'E.) along west boundary of said Lot Seventy-nine (79) a distance of six hundred and sixty (660') feet more or less to the south-west corner of Block Eight (8) of said Lot Seventy-nine (79), thence North eighty-seven degrees forty-five minutes East (N.87°45'E.) along the south boundary of said Lot Eight (8), a distance of One thousand three hundred and thirty-six (1336.0) feet, thence North two degrees nineteen minutes

West (N.2°19'W.) a distance of thirty-three (33') feet, thence South eighty-seven degrees forty-five minutes West (S.87°45'W.) a distance of One thousand three hundred and three (1303.0) feet, thence North two degrees nineteen minutes West (N.2°19'W.) a distance of six hundred and twenty-seven (627') feet more or less to an intersection with the north boundary of said Block nine (9), thence South Eighty-seven degrees forty-five minutes West (S.87°45'W.) along said north boundary a distance of thirty-three (33.0') feet more or less to the point of commencement as shown outlined in red and marked "Road" on the plan attached hereto and prepared by Kenneth B. Wilson, B.C.L.S. and dated the 18th day of July, 1955 and filed in the Land Registry Office, in the City of New Westminster, Province of British Columbia.

2. This By-law may be cited as "BURNABY ROAD DEDICATION BY-LAW NO. 1, 1955".
