

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3637

A BY-LAW to amend By-law No. 1991, being the "Burnaby Town Planning By-law 1948".

WHEREAS applications have been made to the Municipal Council for amendments to By-law No. 1991 being the "Burnaby Town Planning By-law 1948".

AND WHEREAS the Municipal Council has approved the said applications for further consideration and has held a public hearing thereon after notice of the time and place of such public hearing had been duly given.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby in open meeting assembled ENACTS as follows:

1. SCHEDULE 3 of By-law No. 1991 amended by adding the following thereto as clause (rr):

"(rr) Block 3, District Lot 53, save and except the South 125 feet, and save and except the North 14 feet abutting Grange Street."

2. SCHEDULE 3 is further amended by adding the following thereto as clause (ss):

"(ss) Lot "A", except portion on explanatory plan 14361, Block 36, District Lot 122/123, save and except the Northerly 27 feet abutting Parker Street, and the Easterly 20 feet abutting Delta Avenue."

3. SCHEDULE 4 is amended by adding the following thereto as clause (31):

"(31) Lots 21 to 34 inclusive, Block 29, District Lot 122, Map No. 1308."

4. SCHEDULE 5 is amended by adding the following thereto under the heading 'Central Area':

"The West 134 feet of Lot 1, save and except the North 60 feet; the West 167 feet of Lots 2 to 7, save and except the South 40 feet of Lot 7, all of Block 2, District Lot 59, Plan 3798."

5. SCHEDULE 7 is amended by adding the following thereto as clause (s):

"(s) Lots 6 and 7, Block 29, District Lot 117, save and except the south-westerly 14 feet abutting Grandview-Douglas Highway."

6. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 4, 1955".

DONE AND PASSED in Open Council by a two-thirds vote of all the members thereof this Eleventh (11th) day of October, 1955.

RECONSIDERED AND FINALLY PASSED by a two-thirds vote of all the members thereof this Seventeenth (17th) day of October, 1955.
