BY-LAW NO. 3647

A BY-LAW to establish a Board of Park Commissioners for the Municipality.

WHEREAS by Section 361 (1) (a) of the "Municipal Act" R.S.B.C. 1948, it is provided that the Council of any Municipality shall have power to establish a Board of Park Commissioners for the Municipality by a by-law which has been passed by an affirmative vote of three-fourths of all the members of the Council.

AND WHEREAS Council deems it expedient to establish such a Board for this Municipality.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby in open meeting assembled ENACTS as follows:

- 1. There shall be and there is hereby established a
 Board of Park Commissioners for the Municipality of Burnaby.
- 2. The said Board shall consist of five (5) members.
- 3. The first election of members of the said Board shall be held on the Tenth (10th) day of December, 1955.
- 4. The three (3) candidates receiving respectively the highest, second highest and third highest number of votes at the said election shall hold office for the term of two (2) years commencing on the First (1st) day of January, 1956; and the two (2) candidates receiving respectively the fourth highest and fifth highest number of votes shall hold office for the term of one (1) year commencing on the First (1st) day of January, 1956.

- At the regular municipal elections in the year 1956 and in each year thereafter there shall be elected to the said Board for the term of two (2) years, commencing on the First (1st) day of January in the next succeeding year respectively, so many members of the said Board as shall be necessary to fill the vacancies on the said Board which shall be created by the retirement of those members whose term of office shall expire respectively on the Thirty-first (31st) day of December, 1956 and on the Thirty-first (31st) day of December in each succeeding year thereafter.
- 6. This By-law may be cited as the "BURNABY PARK COMMISSION BY-LAW 1955".

DONE AND PASSED by an affirmative vote of threefourths of all the members of the Council this Twenty-sixth (26th) day of September, 1955.

RECONSIDERED AND FINALLY PASSED by an affirmative vote of three-fourths of all the members of the Council this Eleventh (11th) day of October, 1955.
