## THE CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 3704

A BY-LAW for disposing of a portion of a public highway in exchange for a portion of lands adjacent thereto.

WHEREAS pursuant to subsection 260 of section 58 of the Municipal Act Council may pass by-laws for disposing of a public street or highway or any portion thereof in exchange for such adjacent or contiguous lands as may be necessary for the purpose of improving, widening, straightening or diverting any public street or highway, and for executing deeds for the land so given in exchange.

AND WHEREAS all deeds executed under this clause shall have effect as a Crown grant.

AND WHEREAS all lands taken in exchange for any public street or highway or portion thereof under this clause shall be public highways, and the title thereof shall be vested in the Crown.

AND WHEREAS Margaret Jean Mairs is the owner in fee simple of Lot"S" of Blocks Eighty-seven (87) and Eighty-eight (88), of District Lot Ninety-two (92), Group One (1), New Westminster District, according to Plan 5350 deposited in the Land Registry Office in the City of New Westminster, Province of British Columbia.

AND WHEREAS Frederick Charles Aalten is the owner in fee simple of Lot Three (3), of Block Eighty-seven (87), of District Lot Ninety-two (92), Group One (1), New Westminster District, according to Plan 2212 deposited in the said Land Registry Office.

AND WHEREAS it is deemed desirable and in the public interest to dispose of certain portions of the public lane

in Blocks Eighty-seven (87) and Eighty-eight (88), District Lot Ninety-two (92), Group One (1), New Westminster District according to Plan 2212 deposited in the said Land Registry Office upon the terms and conditions hereinafter set forth.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- The Municipal Council of The Corporation of the District 1. of Burnaby is hereby authorized and empowered for the purpose of diverting the said lane to grant and convey unto Frederick Charles Aalten those portions of the said lane which are contiguous to Lot Two (2) of Blocks Eighty-seven (87) and Eightyeight (88), District Lot Ninety-two (92), Group One (1), New Westminster District according to Plan 2212 deposited in the Land Registry Office and to Lot "R" of Blocks Eighty-seven (87) and Eighty-eight (88), District Lot Ninety-two (92), Group One (1), New Westminster District according to Plan 5350 deposited in the Land Registry Office shown outlined in green on the plan hereto attached prepared by David H. Burnett, B. C. L. S., and dated the 20th day of January, 1956, and to accept in exchange therefor that portion of Lot "S" of Blocks Eighty-seven (87) and Eighty-eight (88), of District Lot Ninety-two (92), Group One (1), New Westminster District, according to Plan 5350 deposited and that portion of Lot Three (3) of Block Eighty-seven (87) of District Lot Ninetytwo (92), Group One (1), New Westminster District, according to Plan 2212 deposited and shown outlined in red colour on the plan attached hereto prepared by David H. Burnett, B. C. L. S., and dated the 20th day of January, 1956.
- 2. The aforesaid portions of Lot "S" and Lot Three (3) shall thereupon be and are hereby established as a public street or highway and title thereof shall be vested in the Crown.

- The Reeve and Clerk are hereby authorized and empowered to execute any conveyance, plan or other document on behalf of the Corporation for such purposes, signing the same and affixing the corporate seal thereto.
- 4. This By-law may be cited for all purposes as "BURNABY HIGHWAY EXCHANGE BY-LAW 1956".


