

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3717

A BY-LAW to authorize The Corporation of the District of Burnaby to acquire Easements for Corporate purposes

WHEREAS it is considered desirable and expedient that Easements be acquired for the installation of sewers, drains or other works, through, under and across the lands and premises as set out in the Schedule attached to and forming part of this By-law.

AND WHEREAS the owners of the said respective parcels of land as set out in the said Schedule have agreed to grant an Easement through, under and across their respective properties.

AND WHEREAS Paragraph 19 (a) of Section 58 of the Municipal Act, R. S. B. C. 1948, Chapter 232 authorizes the Council of any Municipality to pass by-laws to acquire easements from any person for and to the use of the Municipality.

THE MUNICIPAL COUNCIL of The Corporation of the District of Burnaby ENACTS as follows:

1. It shall be lawful for the Municipal Council of The Corporation of the District of Burnaby to acquire an easement for the purpose of constructing a sewer, drain or other work from the owners of lands and premises as set out in the Schedule attached hereto and hereby incorporated and made part of this By-law, paying therefor such sums of money as may be mutually agreed upon between the Corporation and the said respective owners.
2. This By-law shall come into force on the registration thereof.
3. This By-law may be cited for all purposes as "BURNABY EASEMENT AUTHORIZATION BY-LAW NO. 4, 1956".

BURNABY EASEMENT AUTHORIZATION BY-LAW NO. 4, 1956

SCHEDULE

1. ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and more particularly known and described as being the North Four (4') feet of Block One Hundred and Fifteen (115) of Lot Ninety-two (92), Group One (1), Plan 1146, New Westminster District, Save and Except part .045 acre and road, Sketch 12925 and being all that portion of said Block One Hundred and Fifteen (115) Save and Except part .045 acre and road, Sketch 12925 lying to the North of a straight line drawn from a point on the Westerly Boundary of aforesaid portion of Block One Hundred and Fifteen (115) and being Four (4') feet to the South of the North-West corner of said Block One Hundred and Fifteen (115) Save and Except part .045 acre and road, Sketch 12925, to a point on the Easterly boundary of the aforesaid portion of Block One Hundred and Fifteen (115) and being Four (4') feet to the South of the North-East corner of said Block One Hundred and Fifteen (115), Save and Except Part .045 acre and road, Sketch 12925.

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and more particularly known and described as being the North Ten (10') feet of Block Seventy-three (73) of Lot Ninety-two (92), Group One (1), Plan 1146, New Westminster District, and being all that portion of said Block Seventy-three (73) lying to the North of a straight line drawn from a point on the Westerly boundary of said Block Seventy-three (73) and being Ten (10') feet to the South of the North-West corner of said Block Seventy-three (73) to a point on the Easterly boundary of said Block Seventy-three (73) and being Ten (10') feet to the South of the North-East corner of said Block Seventy-three (73).
