

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3731

A BY-LAW to authorize the expropriation of certain lands and premises for the widening of Hastings Street in the Municipality of Burnaby.

WHEREAS it is desirable and in the public interest to widen Hastings Street in the Municipality of Burnaby from Boundary Road to Beta Avenue.

AND WHEREAS for such purpose it is necessary to expropriate certain lands and premises abutting upon the said Hastings Street.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered subject to the provisions of Part XIV of the Municipal Act,

(a) To expropriate the lands and premises hereinafter described for the purpose of widening Hastings Street in the Municipality of Burnaby from Boundary Road to Beta Avenue;

(b) By its servants and agents to enter upon, take and use the said lands and premises for such purpose;

(c) By its servants and agents to enter upon any lands and premises which may be injuriously affected by such expropriation for the purpose of executing any works of construction, maintenance, or repair in mitigation of injury done, or apprehended, or in reduction of compensation.

2. The lands and premises expropriated as aforesaid are more particularly known and described as: the North Twenty (20) feet of Lots Three (3), Four (4), Five (5), Seven (7), Eight (8), Nine (9), Ten (10), Sixteen (16), Seventeen (17), and Eighteen (18) of Block Ten (10), District Lot One Hundred and Twenty-one (121), Group One (1), New Westminster District Plan No. 1054.

The North Twenty (20) feet of Lots Sixteen (16), Seventeen (17), and Eighteen (18) of Block Twelve (12), District Lot One Hundred and Twenty-one (121), Group One (1), New Westminster District, Plan No. 1054; and the North Twenty (20) feet of Lots Eight (8) and Twelve (12), Block Nine (9), District Lot One Hundred and Twenty-two (122), Group One (1), New Westminster District, Plan No. 1308.

3. This By-law shall, before coming into effect, be published in the B. C. Gazette and in a newspaper published in the Municipality of Burnaby, and a certified copy thereof shall be filed in the Land Registry Office in the City of New Westminster, Province of British Columbia.

4. This By-law may be cited for all purposes as the "HASTINGS STREET (BURNABY) WIDENING EXPROPRIATION BY-LAW 1956!"
