

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3733

A BY-LAW to amend By-law No. 1991, being the  
Burnaby Town Planning By-law, 1948.

WHEREAS applications have been made to the Municipal Council for amendments to By-law No. 1991, being the "Burnaby Town Planning By-law, 1948."

AND WHEREAS the Municipal Council has approved the said applications for further consideration and has held a public hearing thereon after duly giving notice of the time and place of such public hearing.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby in open meeting assembled ENACTS as follows:

1. Section 16 of By-law No. 1991 is repealed.
2. Schedule One (1) is amended by adding to Section Four (4) thereof, the following as clause (c):  
(c) Lots One (1) and Two (2), Block Eighteen (18), District Lot Sixty-eight (68), Group One (1), New Westminster District, Plan No. 1009.
3. Schedule One (1) is further amended by adding to Section Four (4) thereof, the following as clause (d):  
(d) Lot A, Block Two (2), District Lot One Hundred and Twenty-Two (122), Group One (1), New Westminster District, Plan No. 1308.
4. Schedule Three (3) is amended by adding to clause (o) the words, "save and except Lots One (1) and Two (2), Block Eighteen (18), District Lot Sixty-Eight (68), Group One (1), New Westminster District, Plan No. 1009.
5. Schedule Seven (7) is amended by adding thereto the following as clause (w):  
(w) Lots Three (3) and Four (4), of Lot M of part of Block Three (3), of the South half of Lot Seventy-four (74), Group One (1), New Westminster District, Plan 4313.
6. This By-law may be cited as "BURNABY TOWN PLANNING

BY-LAW, 1948, AMENDMENT BY-LAW NO. 10, 1956".

DONE AND PASSED in Open Council by a Two-thirds (2/3) vote of all the members thereof the Third (3rd) day of July, 1956.
