

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3738

A BY-LAW to amend By-law No. 1991, being the "Burnaby Town Planning By-law 1948."

WHEREAS applications have been made to the Municipal Council for amendments to By-law No. 1991, being the "Burnaby Town Planning By-law, 1948."

AND WHEREAS the Municipal Council has approved the said applications for further consideration and has held a public hearing thereon after duly giving notice of the time and place of such public hearing.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby in open meeting assembled (MEETS) as follows:

1. Schedule 3 of By-law No. 1991 is amended by adding thereto the following as clause (vv):

"(vv) Lot G (explanatory plan 13773), Blocks One (1) and Eight (8), District Lot Four (4) and Block Two (2), South One-half (½) Part South of Lougheed Highway, District Lot Four (4), Plan 845, Group One (1), New Westminster District."

2. Schedule 5 is amended by adding thereto the following under the heading SOUTH AREA:

"Lots Five (5), Six (6), Seven (7), Block One (1), District Lot Sixty-nine (69), Group One (1), New Westminster District, Plan 1558."

3. Schedule 5 is further amended by striking out the first paragraph under the heading NORTH AREA, as amended by By-law 3612, and substituting therefor the following:

"Commencing at a point where Pandora Street intersects Bernet Road, thence South-westerly along Bernet Road to Hastings Street, thence West along Hastings Street to Cliff Avenue, thence South along Cliff Avenue to the North boundary of Lot 1, R. S. D. "A", S.D. 10, Block 4, D. L. 206, thence west along the North boundary of said Lot 1 and continuing west along the North

boundary of Lot "F", S.D. 3/8, Block 4, D. L. 206 to Duncan Avenue, thence South along Duncan Avenue to Union Street, thence East along the North boundary of Lot "A" except plan 10145, Block 1, D. L. 206 to the North-west corner thereof, thence South along the West boundary of said Lot "A" and Lot 4, Block 1, D. L. 206 to Curtis Street, thence West along Curtis Street to Kensington Avenue, thence North along Kensington Avenue to the North-west corner of Lot 5, Block 2, D. L. 206, thence East along the North boundary of said Lot 5 and Lots 4 to 1 inclusive, all of Block 2, D. L. 206 to Perling Avenue to the North-east corner of Lot 1, Block 2, D. L. 206, thence West along the North boundary of said Lot 1 and Lots 2 to 5 inclusive, all of Block 2, D. L. 206 to Kensington Avenue and continuing West along the North boundary of Block "B", D. L. 205, Plan 14671 to Fell Avenue, thence North along Fell Avenue to Pandora Street, thence East along Pandora Street to Valney Avenue and continuing East along Pandora Street projected to Kensington Avenue, thence continuing East along Pandora Street to the point of commencement."

4. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW, 1948, AMENDMENT BY-LAW NO. 11, 1956."
