

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3760

A BY-LAW to authorize the acquisition of certain lands for and to the use of the municipality.



WHEREAS the Municipal Council may by By-law acquire lands from any person for and to the use of the municipality.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from James Edward McDonald by a good and sufficient deed in fee simple for and to the use of the municipality and paying therefor the sum of Twenty-five Hundred (\$2500.00) Dollars those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia more particularly known and described as that portion of Lot One (1), Block One (1), District Lot One Hundred and Twenty-Five (125), Group One (1), District of New Westminster, Province of British Columbia, according to Plan 3520, deposited, and being more particularly described as follows-

Commencing at an iron post set at the Southwesterly corner of Lot One (1), aforesaid;

Thence North $0^{\circ} 19' 30''$ E. and following the Westerly boundary of said Lot One (1), 80.0 feet to an iron post set;

Thence S. $89^{\circ} 52'$ E. and parallel to the Southerly boundary of Lot One (1), aforesaid, 120.0 feet to an iron post set;

Thence S. $0^{\circ} 19' 30''$ W. and parallel to the Westerly boundary of said Lot One (1), 80.0 feet to an iron post set on the Southerly boundary thereof, said post lying 120.0 feet S. $89^{\circ} 52'$ E. of the point of commencement;

Thence N. 89° 52' W. and following the Southerly boundary of Lot One (1), aforesaid, 120.0 feet to the point of commencement, as shown outlined in red on the plan prepared by David H. Burnett, B. C. L.S., sworn the Seventh (7th) day of August, 1956 and filed in the Land Registry Office in the City of New Westminster, Province of British Columbia.

2. This By-law may be cited as "BURNABY LAND ACQUISITION BY-LAW NO. 3, 1956."
