THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3783

A BY-LAW to authorize the acquisition of certain easements for and to the use of the municipality.

WHEREAS the Municipal Council may by By-law acquire easements from any person for and to the use of the municipality.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire easements for and to the use of the municipality through, under and across those certain parcels or tracts of land and premises situate lying and being in the Municipality of Burnaby in the Province of British Columbia more particularly known and described as:

(a) That portion of Lot "A" of Lot Two (2), of Lot "A", Block "C", of Lots Three (3) to Ten (10) and Twelve (12) to Eighteen (18) of District Lot One Hundred and Fifty-seven (157), Group One (1), New Westminster District, Plan 12668 commencing at a point on the Westerly boundary of said Lot "A", said point lying 100.0 feet, S. 2° 18' W. of the Northwesterly corner thereof; Thence S. 88° 14' E. and parallel to the Northerly boundary of Lot "A", aforesaid, Seventy-five (75') feet, more or less to a point on the Easterly boundary of said Lot "A", said point lying 100.0 feet, S. 2° 18' W. of the Northeasterly corner thereof; Thence S. 2° 18' W. and following the Easterly boundary of Lot "A" aforesaid, 13.0 feet; Thence N. 88° 14' W. and parallel to the Northerly boundary of said Lot "A", Seventy-five (75') feet, more or less, to a point on the Westerly boundary of Lot "A", aforesaid, said point lying 13.0 feet, S. 2° 18' W. of the point of commencement; Thence N. 2° 18' E. and following the Westerly boundary of said Lot "A", 13.0 feet to the point

of commencement, as shown on the plan prepared by David H. Burnett, B.C.L.S., dated the Twenty-first (21st) day of September, 1956 and filed in the Land Registry Office in the City of New Westminster, in the Province of British Columbia.

(b) The East four and three tenths (4.3') feet of Lot Twenty-two (22), of Block Thirty-five (35), of District Lots One Hundred and Eighty-eight (188) and One Hundred Eighty-nine (189) and Two Hundred and Eighteen (218), Group One (1), New Westminster District, Plan No. 4953.
