BY-LAW NO. 3794

A BY-LAW to amend By-law No. 1991 being the
"Burnaby Town Planning By-law 1948."

WHEREAS applications were made to the Municipal Council for amendments to By-law No. 1991 being the "Burnaby Town Planning By-law 1948."

AND WHEREAS the Municipal Council approved the said applications for further consideration and held a public hearing thereon after duly giving notice of the time and place of such hearing.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. Paragraph One (1) of Schedule Five (5) of By-law No. 1991 under the heading "South Area", as re-enacted by By-law No. 2027, is struck out and the following substituted therefor:

"All that area bounded on the North by Kingsway; on the East by Edmonds Street; on the South by the British Columbia Electric Railway Central Park right-of-way to Irmin Street, thence by Irmin Street to the South-westerly corner of Block Twenty-seven (27), District Lot Ninety-seven (97), thence North Seventy-three (73') feet along the West boundary of said Block Twenty-seven (27), thence West on a line Forty (40') feet North from and parallel to the Northerly limit of Irmin Street to a point Forty (40') feet East of the Easterly limit of McPherson Avenue, thence North on a line Forty (40') feet from and parallel to the Easterly limit of McPherson Avenue to the Northerly limit of the prolongation of Watling Street, thence by Watling Street to Royal Oak Avenue, thence by Royal Oak Avenue to the British Columbia Electric Railway Central Park right-of-way, thence by the said right-of-way to Olive Avenue; and on the West by Olive Avenue, SAVE AND EXCEPT all those areas zoned as

Commercial and Residential Multiple Family Type I."

2. Paragraph Fifteen (15) of Schedule Five (5), under the heading "South Area", as enacted by By-law No. 3738 is struck out.

3. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 1, 1957."

DONE AND PASSED in Open Council by a two-thirds (2/3) vote of all the members thereof this Twenty-eighth (28th) day of January, 1957.

RECONSIDERED AND FINALLY PASSED by a two-thirds (2/3) vote of all the members thereof this Fourth (4th) day of February, 1957.
