BY-LAW NO. 3802

A BY-LAW to name certain streets within the Municipality of Burnaby.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. The Municipal Council of The Corporation of the District of Burnaby does hereby designate the streets in Schedule "A" of this By-law with the names therein respectively set forth.
2. This By-law may be cited as "BURNABY STREET NAMING BY-LAW 1957."

SCHEDULE "A"

1. The first street North of Broadway between Cliff Avenue and Paulus Crescent - GIBSON STREET.
2. The first street East of Holdom Avenue between Charles Street and Aubrey Street - DUNLOP AVENUE.
3. The first street East of Cliff Avenue at the end of Gibson Street - PAULUS CRESCENT.
4. The first street West of Moore Avenue, South from Halifax Street and also North and South of the Westerly end of Karen Street - YEOVIL AVENUE.
5. The first street West of Cliff Avenue, South from Halifax Street and also North and South of Karen Street - MOORE AVENUE.
6. The first street North of Adair Street, West from Cliff Avenue, OLSON STREET.
7. The first street North of Olson Street, West from Cliff Avenue, KAREN STREET.
8. The street abutting and parallel to the North side of the B.C.E.R. right-of-way between Gilley Avenue and Rumble Street, PRENTER STREET.
9. The first street East of Willingdon Avenue between Kitchener Street and Alpha Avenue - ALPHA DRIVE.
10. The street South-west from Malvern Avenue between Burris Street and Hazard Street - PUNNETT CLOSE.
11. The second street West from North Road, South-west from Lyndhurst Street and ending at Sullivan Street - NOEL DRIVE.
12. The first street East of Noel Drive between Sullivan Street and the end of Casewell Street - ASTOR DRIVE.
13. The street West of North Road between Sullivan Street and Casewell Street and ending at Astor Drive - MAZUCO STREET.
14. The first street South of Lyndhurst Street, South-east from Noel Drive - MARTIN STREET.
15. The first street West of North Road between Sullivan Street and Lyndhurst Street - WILLOUGHBY AVENUE.
16. The first street West of Willoughby Avenue, North from Casewell Street - PRITCHARD AVENUE.

17. Those streets parallel and adjacent to both sides of the B. C. E. B. Central Park right-of-way, from Patterson Avenue to Buller Avenue; and on both sides of the B.C.E. B. right-of-way, from Buller Avenue to Kingsway - BERESFORD STREET.

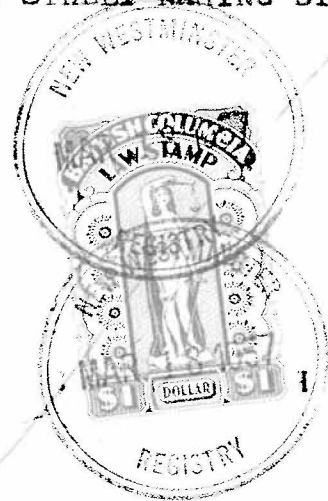
