## BY-LAW NO. 3810

A BY-LAW to amend By-law No. 3658 being the "Burnaby Waterworks Loan By-law 1955."

WHEREAS the Municipal Council of The Corporation of the District of Burnaby finally passed By-law No. 3658 on the Twelfth (12th) day of December 1955, after the said By-law had received the assent of the electors on the Tenth (10th) day of December 1955, to authorize the issue and sale of debentures in the sum of Eight Hundred and Twenty-five (\$825,000.00) Thousand Dollars for the construction of extensions, renewals and improvements to the municipal waterworks system.

AND WHEREAS a true copy of the said By-law No. 3658 duly certified under seal was registered in the office of the County Court of Westminster at New Westminster on the Sixteenth (16th) day of December, 1955.

AND WHEREAS the Municipal Council deems it expedient and in the public interest to amend the said By-law No. 3658 in the manner hereinafter set forth.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:
