THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3822

A BY-LAW to dedicate a portion of certain municipally owned lands for highway purposes.

WHEREAS The Corporation of the District of Burnaby is owner in fee simple of those lands hereinafter described.

AND WHEREAS it is deemed expedient and in the public interest to dedicate the said lands for highway purposes.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. The lands hereinafter described are hereby dedicated as a highway to and for the free use of the public in all times hereafter.
- (a) ALL AND SINGULAR that certain parcel or tract of land and premises situate. lying and being within the Municipality of Burnaby in the Province of British Columbia and being all that portion of Parcel "A", Block Two (2), District Lot Two Hundred and Five (205), Group One (1), New Westminster District Plan No. 14671 commencing at a point on the southerly boundary of the said Parcel "A" one hundred and fifty four and seventy four hundredths (154.74) feet easterly thereon from the southwesterly corner thereof, thence North Seventy four (74°) degrees, thirty eight (38) minutes and thirty (30) seconds West forty four and thirty two hundredths (44.32) feet; thence on a curve to the left of five hundred and forty and sixty nine hundredths (540.69) feet radius, to which the aforesaid course is tangent, one hundred and thirteen and fifty three hundredths (113.53) feet, more or less, to the westerly boundary of the said Parcel "A"; thence northerly along the said westerly boundary sixty six and five hundredths (66.05) feet; thence south easterly on a curve concentric with and radially distant sixty six (66) feet from the aforesaid curve one hundred and thirty and sixty three hundredths (130.63) feet; thence South seventy four (74) degrees twenty eight (28)

minutes and thirty (30) seconds East on a tangent to the last named curve, two hundred and eight and seven tenths (208.7) feet; thence on a curve to the left of radius five hundred and forty and sixty nine hundredths (540.69) feet, to which the last named course is tangent, one hundred and forty six and twenty seven hundredths (146.27) feet, more or less, to a tangental point thereto on the southerly boundary of said Parcel "A", and thence westerly thereon three hundred and twenty and fifty four hundredths (320.54) feet, more or less, to the point of commencement, the whole containing four hundred and forty three thousandths (0.443) acres, more or less as shown outlined in red on the plan hereto attached prepared by Ernest C. W. Lamarque, B. C. L. S., and sworn the Fifth (5th) day of April, 1957 and filed in the Land Registry Office in the City of New Westminster in the Province of British Columbia.

2. This By-law may be cited as "BURNABY ROAD DEDICATION BY-LAW NO. 2, 1957."
