BY-LAW NO. 3846

A BY-LAW to amend By-law No. 3325 being the "Burnaby Waterworks Regulation Bylaw 1953."

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. Section One (1) of By-law No. 3325 is amended by striking out all the words after "building" in the definition of "duplex house" or "double house" and substituting therefor "used or designed to be used by two families."

2. By-law No. 3325 is further amended by adding thereto the following as Clause 6A.

"6A. Every consumer shall provide for each service to his premises a pressure reducing value and a pressure relief value upon the request of the Engineer whenever the water pressure in the main serving his premises shall be or become so great as may cause damage."

3. Section Twelve (12) is repealed and the following substituted therefor:

"12. (1) No person, except an employee of the Municipality in the course of his employment, shall without the written authority of the Engineer open any hydrant or stand pipe or use water therefrom. Such authority shall reserve the right of the Municipality to stop such use at any time for any reason without liability for damages resulting therefrom in any manner whatsoever.

(2) Every person who receives such authority shall deposit with the Engineer a cash bond of Twenty-five (\$25.00) Dollars and the Corporation may deduct from such cash bond whatever charges shall be payable to the Corporation for the use of water and for damages to the hydrant or stand pipe.

(3) Every person who uses water from any hydrant or stand pipe shall pay therefor to the Corporation on demand the minimum charge of Five (\$5.00) Dollars or the sum of Two (\$2.00) Dollars per day of such use, or any part thereof, whichever sum shall be greater."

4. Section Forty (40) is repealed and the following substituted therefor:

"40. The Treasurer shall render accounts for water supplied through a meter monthly or quarterly and such accounts shall be payable on or before the Twenty-fifth (25th) day of the month in which rendered."

5. Schedule "A" is amended by striking out under the heading "Meter Rates", the second paragraph commencing "Discount of ten percent;" and by striking out in the third paragraph commencing "Minimum monthly charge" the words and figures, "subject to a discount of 15¢ if paid by due date."

6. Schedule "A" is further amended by striking out under the heading "Quarterly Meter Rates" in the third line thereof the words, "less ten per cent discount if paid by due date," and in the fourth and fifth lines thereof the words and figures, "less 45¢ discount if paid by due date."

7. Schedule "A" is further amended by striking out the Section headed "Meter Rentals" and substituting therefor the following:

"<u>METER RENTALS</u>

The following rents shall be charged for meters in addition to the charge for water use:

8. Schedule "A" is further amended by striking out the section headed "Connection Fees" and substituting therefor the following:

CONNECTION FEES

Fees payable for water service connections: Up to and including 3/4" connection....\$ 60.00 For a 1" connection..... 90.00

Over 2" - Total cost of installation."

This By-law may be cited as "BURNABY WATERWORKS 9. REGULATION BY-LAW 1953, AMENDMENT BY-LAW 1957."
