

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3891

A BY-LAW to authorize the acquisition of certain real property for and to the use of the Municipality for municipal purposes.

WHEREAS the Council may by by-law, subject to the restrictions in the Municipal Act contained, acquire by purchase, gift, lease, or otherwise any real property and rights, easements or privileges in and to real property from Canada or the Province for and to the use of the municipality for municipal purposes.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY LAND ACQUISITION BY-LAW NO. 5, 1957."

2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered for drainage purposes to acquire by a good and sufficient deed in fee simple from the registered owners thereof, paying therefor the sum of \$1.00, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and more particularly known and described as all that portion of Lot "E", of Lots 6, 7, 8 and 9, of Blocks 34, 35, and 36, of District Lot 35, Group 1, New Westminster District, according to Plan 16294, deposited,

Commencing at the Southwest corner of Lot 10, according to Plan 1370, deposited;

Thence N. 1° 47' E. and following the Westerly boundary of said Lot 10, 80.0 feet;

Thence N. 88° 00' W. and parallel to the Southerly boundary of Lot "E", aforesaid, 190.69' more or less, to a point lying on the Easterly boundary of Lot "A", according to Explanatory Plan 11824, deposited, said point lying 80.0 feet, N. 1° 47' E. of the Southeasterly corner thereof,

Thence S. 1° 47' W. and following the Easterly boundary of said Lot "A", 80.0 feet, to the Southeasterly corner thereof;

Thence S. 88° 00' E. and following a portion of the Southerly boundary of Lot "E", aforesaid, 190.69 feet, more or less to the point of commencement, and containing by admeasurement 0.35 of an acre, be the same more or less, as shown outlined in red on the plan prepared by David H. Burnett, B. C. L. S. dated the 18th day of July, 1957, deposited in the Land Registry Office in the City of New Westminster, in the Province of British Columbia.

Read a second time this 16th day of September, 1957.

Read a third time this 16th day of September, 1957.
