

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3893

A BY-LAW to amend By-law No. 1991 being the  
"Burnaby Town Planning By-law 1948."

WHEREAS applications for rezoning have been made  
to the Municipal Council.

AND WHEREAS the Municipal Council has held a public  
hearing thereon after duly giving notice of the time and  
place of such hearing.

NOW THEREFORE the Municipal Council of The Corpora-  
tion of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TOWN PLANNING  
BY-LAW 1948, AMENDMENT BY-LAW NO. 8, 1957."

2. Section 3 of Schedule 1 of By-law No. 1991, as  
enacted by By-law No. 3612, is amended

(a) by adding the following as clause (bb):

"(bb) Lot 3, Block 89, District Lot 127, Group  
1, New Westminster District, Plan 4953."

(b) by adding the following as clause (cc):

"(cc) All that area bounded on the north by the  
lane north of Arcola Street, on the east by Griffiths Avenue,  
on the south by the lane south of Arcola Street and on the  
west by the lane east of Sperling Avenue."

3. Subsection (b) of section 4 of Schedule 1 is amended  
by adding the following:

"Save and except all that area bounded on the north  
by the lane north of Arcola Street, on the east by Griffiths  
Avenue, on the south by the lane south of Arcola Street and  
on the west by the lane east of Sperling Avenue."

4. Schedule 5, as enacted by By-law No. 2027, is amended  
by adding the following under the heading "Central Area."

"Lot 'B' of Lot 2, Block 1, of Lot 77, Group 1, New

Westminster District, Plan 4108, save and except that part subdivided under Plan No. 13194."

5. Schedule 7, as enacted by By-law No. 3157, is amended by striking out clause (cc) as enacted by By-law No. 3835.

Read a first time this 16th day of September, 1957.

Read a third time this 16th day of September, 1957.

Reconsidered and adopted by an affirmative vote of two-thirds of all the members of the Council this 7th day of October, 1957.
