BY-LAW MO. 3893

A BY-LAW to smend By-lew No. 1991 being the "Burnaby Your Planning By-law 1948."

WHEREAS applications for rezoning have been made to the Municipal Council.

AND WHEREAS the Municipal Council has held a public hearing thereon after duly giving notice of the time and place of such hearing.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNARY TOWN FLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 8, 1957."
- 2. Section 3 of Schedule 1 of By-law No. 1991, as enseted by By-law No. 3612, is smended
- (a) by adding the following as clause (bb):

 "(bb) Lot 3, Block 89, District Lot 127, Group

 1. New Westminster District, Flan 4953."
 - (b) by adding the following as clause (cc):
- "(oc) All that area bounded on the north by the lane north of Aroola Street, on the east by Griffiths Avenue, on the south by the lane south of Aroola Street and on the west by the lane east of Sperling Avenue."
- 3. Subsection (b) of section 4 of Schedule 1 is amended by adding the following:

"Save and except all that area bounded on the north by the lane north of Arcola Street, on the east by Griffiths enue, on the south by the lane south of Arcola Street and on the west by the lane east of Sperling Avenue."

4. Schedule 5, as enseted by By-lew No. 2027, is exended by adding the following under the heading "Central Area."

"Lot 'B' of Lot 2, Block 1, of Lot 77, Group 1, New

Westminster District, Plan 4108, save and except that part subdivided under Plan No. 13194."

5. Schedule 7, as enected by By-law No. 3157, is amended by striking out clause (oc) as anacted by By-law No. 3835.
