THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3911

A BY-LAW to dispose of certain portions of highway in exchange for other lands.

WHEREAS the Municipal Council may by by-law dispose of any portion of a highway in exchange for such lands as may be necessary for the purpose of improving, widening, straightening, relocating or diverting the highway.

AND WHEREAS the Municipal Council, before adopting this by-law, has caused public notice of its intention to be given by advertisement in The British Columbian, a news-paper circulating in the Municipality, on the 21st day of November 1957 and on the 28th day of November, 1957.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY HIGHWAY EXCHANGE BY-LAW NO. 5. 1957."
- 2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered for the purpose of relocating 18th Street to dispose of those portions of the said 18th Street more particularly described as portions of District Lot 53, Group 1, New Westminster District, Plan 3037 lying adjacent to Lots "B" and "C" respectively of Block 2, Plan 3752 and each containing by estimation 0.20 of an acre be the same more or less as shown outlined in green on the plan hereunto annexed prepared by David H. Burnett, B. C. L. S., dated the 31st day of August, 1957 IN EXCHANGE FOR those portions of the said Lot "B" and the said Lot "C" having a full

width of 66 feet lying immediately adjacent to the northeasterly boundaries thereof and each containing by estimation 0.20 of an acre be the same more or less as shown outlined in red on the aforesaid plan.
