

## THE CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 3917

A BY-LAW to exempt from taxation a portion of certain lands within the municipality.

WHEREAS Temple Collegiate has a registered right to purchase Lot "B", Block 1, Lot 79, Group 1, Plan 6642, and Lot 2, of Lot 79, Group 1, Plan 536, New Westminster District.

AND WHEREAS the said Temple Collegiate is an incorporated institution of learning regularly giving to children instruction accepted as equivalent to that furnished in a public school.

AND WHEREAS the said Temple Collegiate is in actual occupation of certain buildings upon the said lands.

AND WHEREAS the said buildings are wholly in use for the purpose of such instruction.

AND WHEREAS the Municipal Council deems that a portion of the said lands hereinafter described is reasonably necessary in connection therewith.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TAXATION EXEMPTION BY-LAW 1957."
2. The Municipal Council of The Corporation of the District of Burnaby does hereby exempt from taxation for the year 1958 ALL AND SINGULAR those two certain parcels or tracts of land and premises situate, lying and being Lot "B" of Block 1, according to Plan 6642 deposited, and a portion of Block 2, according to Plan 536 deposited, both of Lot 79, Group 1, New Westminster District, and

being more particularly described as follows:

FIRSTLY

COMMENCING at the northwest corner of Lot "B" of Block 1 aforesaid; thence S. 89° 52' E. and following the northerly boundary of said Lot "B" 124.3 feet; thence S. 44° 57' E. and following the northeasterly boundary of said Lot "B" 121.1 feet; thence south and following the east boundary of said Lot "B" 226.0 feet to the southeast corner thereof; thence west and following the south boundary of said Lot "B" 210.0 feet to the southwest corner thereof; thence north and following the west boundary of said Lot "B" 312.0 feet to the point of commencement and containing 1.42 acres, be the same more or less, as shown outlined in red colour on the plan hereto annexed, dated December 9, 1957, prepared by Geoffrey K. Burnett, B. C. L. S., and filed in the Land Registry Office in the City of New Westminster, Province of British Columbia.

SECONDLY

COMMENCING at the northeast corner of Block 2 aforesaid; thence south and following the east boundary of said Block 2, 360.0 feet; thence N. 89° 52' W. and parallel to the northerly boundary of said Block 2, 130.0 feet; thence north and parallel to the east boundary of said Block 2, 360.0 feet to a point on the northerly boundary thereof; thence S. 89° 52' E. and following the northerly boundary of said Block 2, 130.0 feet to the point of commencement and containing by estimation 1.074 acres, be the same more or less, as shown outlined in red colour on the aforesaid plan.
