BY-LAW NO. 3929

A BY-LAW to stop up and close to traffic portions of certain highways within the municipality.

WHEREAS Napier Street and Aubrey Street are constructed at an extreme grade between Fell Avenue and Holdom Avenue.

AND WHEREAS it is therefore desirable and in the public interest to stop up and close to traffic those portions of the said Napier Street and Aubrey Street hereinafter described and to establish inplace thereof two new highways extending from Charles Street to Curtis Street.

AND WHEREAS the consent has been obtained of the owners of lands adjoining the aforesaid portions of the said Napier Street and Aubrey Street.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW 1958."

2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to stop up and close those portions of Napier Street and Aubrey Street shown outlined in red colour on the plan hereto annexed, prepared by Kenneth B. Wilson, B. C. L. S., and dated the 16th day of October, 1957.

3. The said portions of Napier Street are more particularly described as:

(a) Commencing at a point on the south boundary of Napier Street which point is S 89° 56' 18" W a distance of 142.0 feet from the west boundary of Fell Avenue thence, S 89° 56' 18" W along said south boundary a distance of 122.0 feet

and extending the full width of Napier Street.

(b) Commencing at a point on the south boundary of Napier Street which point is S 89° 56' 18" W a distance of 330.0 feet from the west boundary of Fell Avenue thence, S 89° 56' 18" W along said south boundary a distance of 388.0 feet and extending the full width of Napier Street.

(c) Commencing at a point on the south boundary of Napier Street which point is S 89° 56' 18" W a distance of 738.0 feet from the west boundary of Fell Avenue thence S 89° 56' 18" W along said south boundary a distance of 120.0 feet and extending the full width of Napier Street.

(d) Commencing at a point on the south boundary of Napier Street which point is S 89° 56' 18" W a distance of 924.0 feet from the west boundary of Fell Avenue thence, S 89° 56' 18" W along said South Boundary a distance of 122.0 feet and extending the full width of Napier Street.

4. The said portions of Aubrey Street are more particularly described as:

(a) Commencing at a point on the south boundary
of Aubrey Street which point is S 89° 56' 18" W a distance
of 330.0 feet from the west boundary of Fell Avenue thence,
S 89° 56' 18" W along said south boundary a distance of 388.0
feet and extending the full width of Aubrey Street.

(b) Commencing at a point on the south boundary of Aubrey Street which point is S 89° 56' 18" W a distance of 738.0 feet from the west boundary of Fell Avenue thence, S 89° 56' 18" W along said south boundary a distance of 120.0 feet and extending the full width of Aubrey Street.

(c) Commencing at a point on the south boundary of Aubrey Street which point is S 89° 56' 18" W a distance of 924.0 feet from the west boundary of Fell Avenue thence, S 89° 56' 18" W along said south boundary a distance of 122.0 feet and extending the full width of Aubrey Street.

(d) Commencing at a point on the south boundary of Aubrey Street which point is S 89° 56' 18" W a distance of 1066.0 feet from the west boundary of Fell Avenue thence, S 89° 56' 18" W along said south boundary a distance of 186.47 feet more or less to an intersection with the east boundary of Holdom Avenue and extending the full width of Aubrey Street.

5. By-law No. 3840 and By-law No. 3864 are repealed.
