

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3936

A BY-LAW to acquire certain lands within the Municipality and dedicate the same for highway purposes.

The Municipal Council of The Corporation of the District of Burnaby EMA 78 as follows:

1. This by-law may be cited as "BURNABY 2001. PLAN 1- HIGHWAY DEDICATION BY-LAW NO. 2, 1958."
2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, in consideration of \$1.00, those lands situate, lying and being in the Municipality of Burnaby, Province of British Columbia, more particularly known and described as that portion of Parcel "A" (reference Plan 13737) of Lot 9, Block 40, of Lot 189, Group 1, Plan 4953, New Westminster District, commencing at a point on the east boundary of the said Lot "A" distant 9.58 feet north $4^{\circ} 24'$ E from the most southerly corner of the said Lot "A"; thence S $4^{\circ} 24'$ W, 9.58 feet to the said most southerly corner of the said Lot "A"; thence N $55^{\circ} 13'$ E, along the south-east boundary 15.25 feet to a point; thence N $85^{\circ} 59' 40''$ W, 11.84 feet more or less to the point of commencement as shown outlined in red on the plan hereunto attached prepared by A. J. Tolliday, B. C. L. S., dated the 27th day of January, 1958.
3. Upon registration of the said deed in the Land Registry Office in the City of New Westminster, in the Province of British Columbia, the said lands shall be established as a public highway.

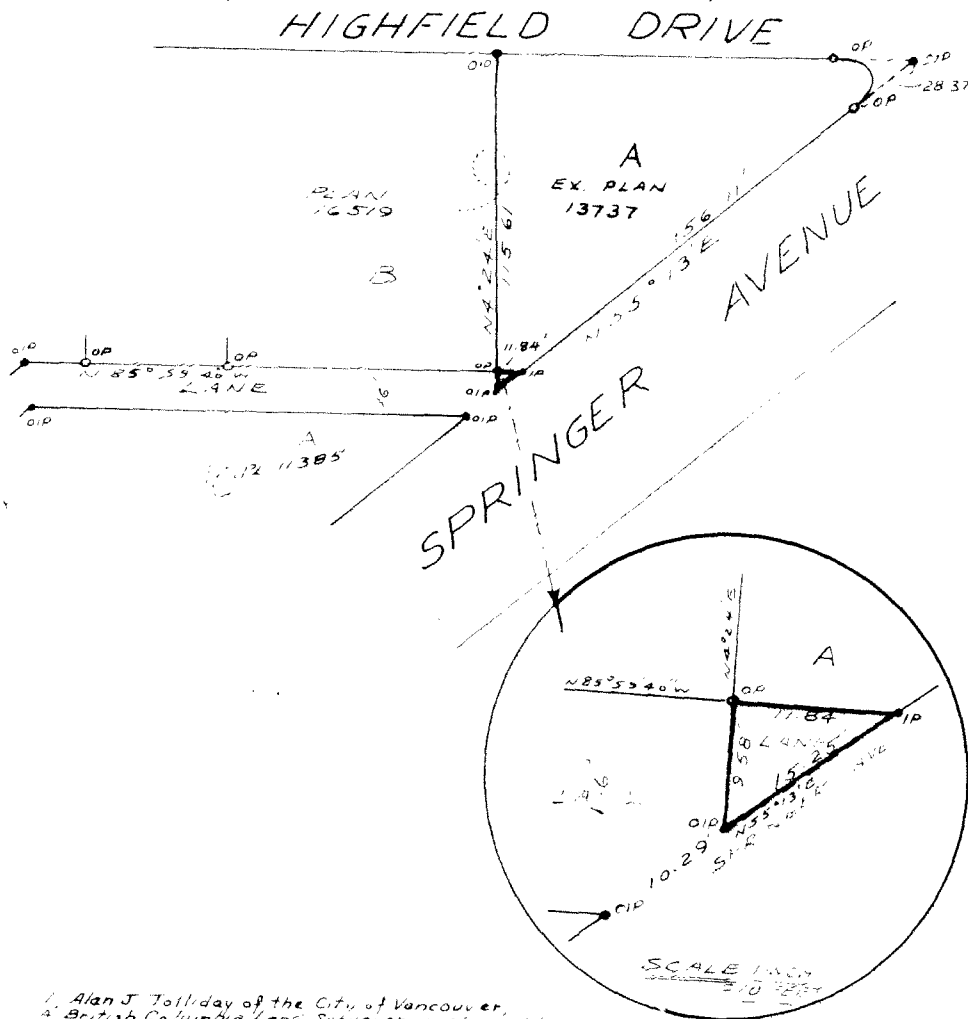
