and when sas the Municipal Council deems it in the public interest to acquire for such purpose the lands hereinofter described.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby | NACTS as follows:

- 1. This By-law may be cited as "BUENABY LAND ACCUISITION BY-LW NO. 1, 1958."
- The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from Her Asjesty The Sucen in the right of Canada by Crown grant, paying therefor the sum of \$8,390.50, those lands situate, lying and being in the Municipality of Burnaby, Province of British Columbia known as Parcel "D" (Reference Plan 15815) of Blocks 15, 16, 17, 18, 19, 20 and 21, of Lot 11, Group 1, New Westminster District, Plan 3045, being more particularly described as follows:

Commencing at a point which is the southwesterly corner of Lot 1, of Block 15;

Thence N 39° 5' W along the westerly boundary of the said Block 15, 195 feet;

Thence E 50° 25' E a distance of 1773.66 feet to a point on the easterly boundary of Dlock 21;

Thence S 40° 6° 43° E along the easterly boundary of the said Block 21 a distance of 195 feet to the southeasterly corner of the said Block 21;

Thence S 50° 25' W along the southerly boundaries of the said Blocks 21, 20, 19, 18, 17, 16 and 15, a distance of 1777.10 feet to the point of commencement, and all those portions of streets, avenues and lanes lying within the hereinbefore described boundaries, as shown outlined in red on the plan prepared by Kenneth B. Wilson. B. C. L. S., dated the 9th day of July 1957 and deposited in the Land Begistry Office in the City of New Westminster, Province of British Columbia with application number 403490-5.
