BY-LAW NO. 3949

A BY-LAW to authorize the sale of certain municipally owned lands.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY LAND SALE BY-LAW NO. 6, 1958."
2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to sell to the purchasers named in Schedule "A" hereof the lands therein more particularly described for the purchase price and upon the terms therein more particularly set forth, and the Reeve and Clerk are hereby authorized and empowered to execute and deliver all documents necessary in connection therewith.
