BY-LAW NO. 3959

A BY-LAW to authorize the sale of certain municipally-owned lands.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY LAND SALE BY-LAW NO. 9, 1958."
- 2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to grant and convey by a good and sufficient deed in fee simple unto George Frederick Rumble and Gwendolyn Loreen Rumble in consideration of the sum of one dollar and upon condition that the lands hereinafter described be consolidated with Lot "A", Plan 8599, those lands and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia and more particularly known and described as being that portion of part of Lot 18, Block 2, District Lot 25, Group 1, New Westminster District, Plan 2062 commencing at the most westerly corner of part of Lot 18, aforesaid;

Thence southeastwardly and following the southwesterly boundary of said part of Lot 18, 126.8 feet, more or less, to the most southerly corner thereof;

Thence northeastwardly and following the southeasterly boundary of part of Lot 18, aforesaid, 15.0 feet;

Thence northwestwardly and parallel to the southwesterly boundary of part of Lot 18, aforesaid, 126.8 feet,
more or less, to a point on the northwesterly boundary
thereof, said point lying 15.0 feet northeastwardly from
the point of commencement;

Thence southwestwardly and following the north-westerly boundary of said part of Lot 18, 15.0 feet to the point of commencement, and containing by estimation 0.044

of an acre, be the same more or less, as shown on the plan hereunto annexed prepared by David H. Burnett, B. C. L. S., dated the 4th day of March, 1958.
