THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3970

A BY-LAW to regulate the closing hours of shops.

WHEREAS the Municipal Council may regulate shops to the extent provided in Division (3) of Part XXVIII of the Municipal Act, Statutes of British Columbia 1957 and Amendments thereto.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY SHOPS CLOSING BY-LAW 1958".

2. The Municipal Council does hereby define the classes of shops set out hereunder:

(a) "Corner or Neighbourh od Shop" means a shop having a shopping floor area of less than 1000 square feet, operated by a family where not more than one other employee, whole or part-time, is engaged, which carries and sells articles commonly sold in grocery stores, including magazines, tobacco products, soft drinks, ice cream and confectionery.

(b) "Marinas" means a shop where the principal articles for sale are those commonly used as camping equipment, including boats, tents, tarpaulins, canned ice, camping clothing peculiar to safety only, shoes, ski equipment, outboard motors, gasoline stoves and lanterns, and ship chandlery.

(c) "Drug Stores" shall mean shops within which a Registered Pharmacist is in attendance at all times with the exception of drug departments within department-stores.

3. The Municipal Council does hereby exempt completely from the provisions of sections 866 and 867 of the Municipal Act the classes of shops defined in section 2 of this by-law. 4. All shops as defined in section 865 of the Municipal Act shall be closed and remain closed for the serving of customers:

(a) on Monday, Tuesday, Wednesday, Thursday and Saturday of each week not later than six o'clock in the afternoon.

(b) on Friday not later than nine o'clock in the afternoon.

5. Notwithstanding anything in this by-law contained, barber shops and hairdressing shops shall be closed and remain closed for the serving of customers:

(a) on Tuesday, Wednesday, Thursday, Friday and Saturday not later than six o'clock in the afternoon.

(b) on Monday for the entirety of the said day, provided that when a holiday as defined in section 866 of the Municipal Act occurs in any week and does not fall on Monday, such shops may remain open on Monday in that week until the hour of six o'clock in the afternoon.

6. Notwithstanding anything in this by-law contained all shops may remain open for the serving of customers until the hour of nine o'clock in the afternoon on any or all of the seven business days immediately preceding Christmas Day, and on any day immediately preceding a holiday as defined in section 866 of the Municipal Act when such holiday falls on a Friday.

7. Any person found guilty of an infraction of any of the provisions of this by-law shall be liable to a fine not exceeding one hundred dollars or in default, to imprisonment not exceeding thirty days.

8. By-law No. 3951 is hereby repealed.
