THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3973

A BY-LAW to name certain streets within the Municipality of Burnaby.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY STREET NAMING BY-LAW 1958".
2. The Municipal Council of The Corporation of the District of Burnaby does hereby designate the streets in Schedule "A" of this by-law with the names therein respectively set forth.
3. The Municipal Council does hereby change the name of:
  - (a) Edna Street to Grange Street.
  - (b) Cade Street to Arbor Street.
  - (c) Twenty-first Avenue to Byrne Road.
  - (d) Sellar Street to Sellar Avenue.
  - (e) Mazucc Street to David Drive.
  - (f) Twentieth Avenue, between Bevan Street and Twentieth Street, to Nineteenth Avenue.
  - (g) Clayton Avenue, between Grandview-Douglas Highway and Rugby Street, to Chiselhampton Street.

1. First street north of Grassmere Street, east from Pioneer Avenue -  
HARKEN STREET.
2. First street west of Arden Avenue, north and east from Curtis  
Street - CENTENNIAL WAY.
3. First street south from Kitchener Street between Augusta Avenue and  
Duthie Avenue - HATTON AVENUE.
4. The cul-de-sac south from Stanley Street between Sperling Avenue and  
Griffiths Avenue - ASHWORTH COURT.
5. First street north of Burford Street, East from Griffiths Avenue -  
BRYANT COURT.
6. First street north of Dover Street, northwest from Royal Oak Avenue  
and connecting with Nelson Avenue - FORGLEN DRIVE.
7. First street north of Forglen Drive, northwest from Royal Oak Avenue -  
O'KELLY DRIVE.
8. First street south of Greenwood Street, west from Bainbridge Avenue -  
HILLVIEW STREET.
9. First street west from Cliff Avenue between Winch Street and Halifax  
Street - LOONDALE STREET.
10. The street northeast from Barnet Highway to Canadian Pacific Railway  
right-of-way, south of McColl-Frontenac Oil Company plant - McCOLL DRIVE.
11. First street west of Grandview-Douglas Highway, north from Elwell  
Street - KOALA COURT.
12. First street north of Government Street, west from Lakedale Avenue -  
HUNTER STREET.
13. First street north from Serdis Street to Bond Street between Elson and  
Booth avenues - BRINGTON AVENUE.
14. First street east of Cumberland Street, south from Armstrong Avenue -  
TAYLOR PLACE.
15. First street south from Berwick Street between Kisbey Avenue and  
Waltham Avenue - DICKENS PLACE.
16. First street south from Southwood Street between Sussex Avenue and  
Dow Avenue - SOUTHWOOD PLACE.
17. First street north of Government Street, east from Phillips Avenue -  
COLLEEN STREET.

18. First street east of Phillips Avenue, north from Colleen Street -  
CHRISDALE AVENUE.
19. First street north of Colleen Street, east from Chrisdale Avenue -  
CHUTEK STREET.
20. First street east of Royal Oak Avenue, north from Gilpin Street -  
GATSBY AVENUE.
21. First street east from Willoughby Avenue between Caswell Street  
and Lyndhurst Street - MARTIN COURT.
