

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3974

A BY-LAW to acquire certain lands within the Municipality and dedicate the same for highway purposes.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 3, 1958".
2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, in consideration of the sum of one dollar (\$1.00), those lands situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and being more particularly known and described as the east thirty-three feet of the north half of Block 45, of Lot 33, Group 1, New Westminster District, Plan 944, save and except the south 121.8 feet and the west ten feet thereof as shown outlined in red on the plan hereto annexed prepared by K. K. Wong, B. C. L. S., dated the 17th day of July 1958.
3. Upon registration of the said deed in the Land Registry Office in the City of New Westminster, in the Province of British Columbia, the said lands shall be established as a public highway.

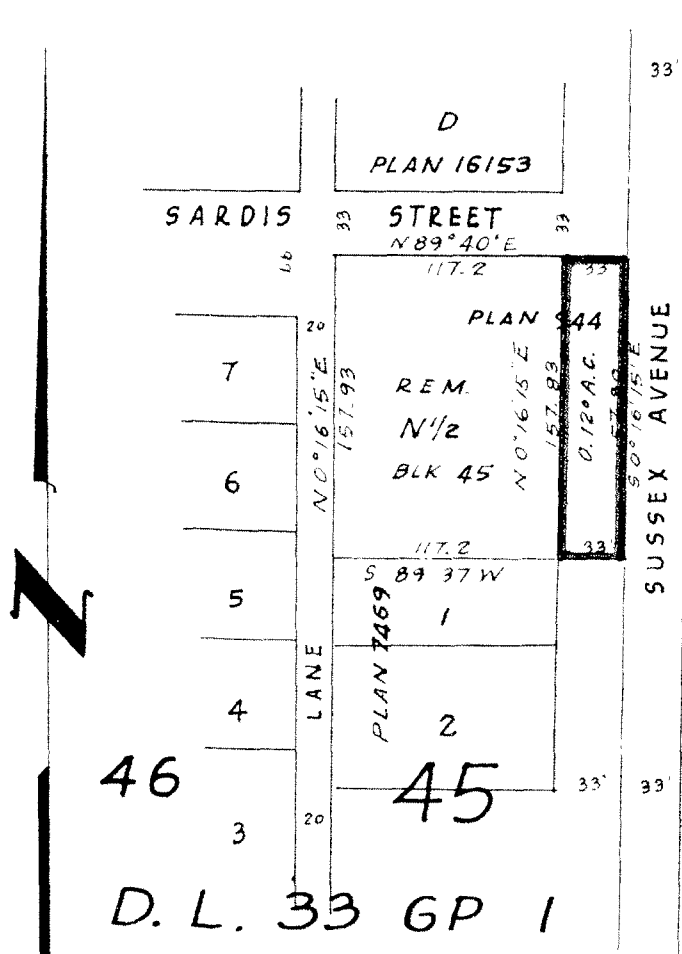
