BY-LAW NO. 4011

A BY-LAW to authorize the sale of certain municipally-owned lands.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY LAND SALE BY-LAW NO. 18, 1958."
2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to grant and convey by a good and sufficient deed in fee simple unto Alfred Hope Clary and Nicholas Kalyk those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and more particularly known and described as Blocks 22 and 49 of Lots 32 and 82, Group 1, Plan 17168, New Westminster District and in consideration therefor to acquire from the said Alfred Hope Clary and Nicholas Kalyk by a good and sufficient deed in fee simple those lands and premises situate, lying and being in the said Municipality of Burnaby, more particularly known and described as Lots 13 and 14, of Blocks 18 and 20, of Lot 32, Group 1, Plan 18542, New Westminster District.
3. The Municipal Council is further authorized and empowered to grant and convey by a good and sufficient deed in fee simple unto Bel-Air Construction Co. Ltd. those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and more particularly known and described as Lots 3 to 7 inclusive, Block 17, District Lot 30, Group 1, Plan 3036, New Westminster District, in consideration of the sum of \$400.00 and in

further consideration therefor to acquire from the said Bel-Air Construction Co. Ltd. by a good and sufficient deed in fee simple those lands and premises situate, lying and being in the said Municipality of Burnaby and more particularly known and described as Lot 11, measuring 160 feet by 110 feet as shown on a plan of subdivision of Lot 7 of Parcel 1, of Lot "C" of Blocks 15 and 16, according to Plan 16317, and of Lots 3 to 7 inclusive, Plan 3036, part of the west 80 feet of Lot "A", Plan 10572, and of a portion, formerly lane, shown outlined in red on plan with by-law filed 47058, all of Block 17; and of Block 18, Lot 30, Group 1, New Westminster District, prepared by David H. Burnett, B. C. L. S., dated the 8th day of October 1958 and deposited in the Land Registry Office in the City of New Westminster, in the Province of British Columbia.
