

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4013

A BY-LAW to acquire certain lands within the Municipality and dedicate the same for highway purposes.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 6, 1958".
2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from The Trustees for Cliff Avenue Congregation of the United Church of Canada in consideration of the sum of one (\$1.00) dollar, those lands, situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and more particularly known and described as that portion of Lot 60 of Lot 135, Group 1, Plan 3234, New Westminster District, commencing at the northwest corner of said Lot 60, thence south $89^{\circ} 56'$ east along the northerly boundary of said Lot 60, 263.6 feet, more or less, to a point on a line drawn parallel to and distant 33 feet measured perpendicularly westerly from the easterly boundary of said Lot 60; thence south $0^{\circ} 30'$ west and parallel to the easterly boundary of said Lot 60, 145 feet, more or less, to a point on a line drawn parallel to and distant 20 feet measured perpendicularly northerly from the southerly boundary of said Lot 60; thence north $89^{\circ} 56'$ west and parallel to the southerly boundary of said Lot 60; 263.16 feet, more or less, to a point on the westerly boundary of said Lot 60; thence north $0^{\circ} 19' 30''$ east along the westerly boundary of said Lot 60; 145 feet, more or less, to the point of commencement; containing 0.877 of an acre, be the same more or less, as shown outlined in red on the plan annexed hereto prepared by K. K. Wong, B. C. L. S., dated the 13th day of November 1958.

3. Upon registration of the said plan in the Land Registry Office in the City of New Westminster, in the Province of British Columbia, the said lands shall be established as a public highway.

Read a first time this 1st day of December, 1958.

Read a second time this 1st day of December, 1958.

Read a third time this 1st day of December, 1958.

Reconsidered and adopted this 8th day of December 1958.



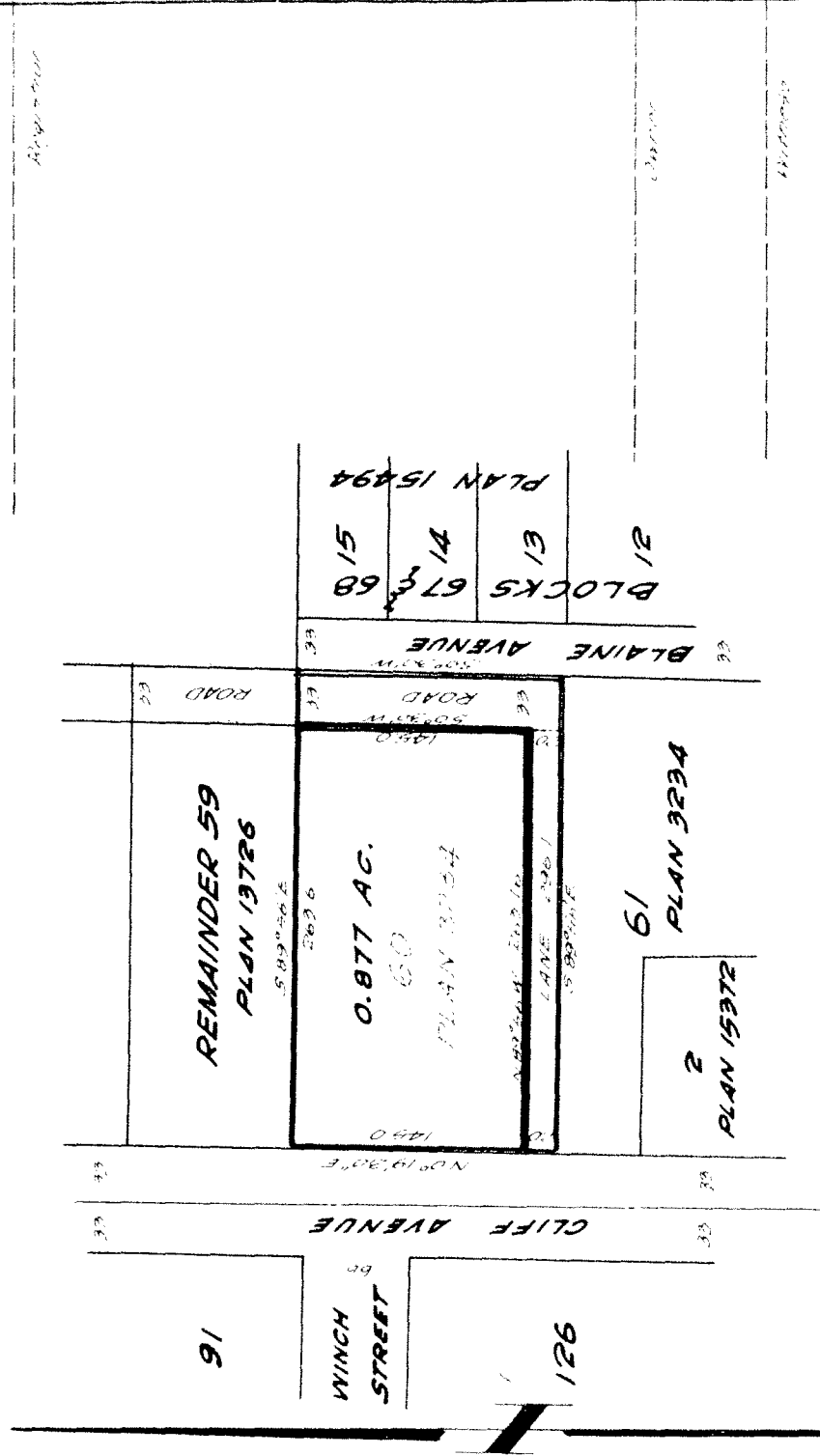
