WHEREAS notice of intention of the Council to undertake the construction, as a local improvement, of the works hereinafter described has been duly given by publication of the notice and by service of it upon the owners of the parcels liable to be specially charged. AND WHEREAS the Clerk has filed a statutory declaration proving publication and service of the said notice. AND WHEREAS no petition against the said works, signed by a majority of the owners, representing at least one-half of the land value of the parcels which are liable to be specially charged, has been presented. AND WHEREAS the Council has had prepared in respect of the said works the reports required by section 600 of the Municipal Act. AND WHEREAS the total cost of the said works is estimated to be \$158.535.00. AND WHEREAS the owners' share of the said cost is estimated to be \$95,195.60.

AND WHEREAS the Corporation's share of the said cost is estimated to be \$63,339.40.

AND WHEREAS the lifetime of the said works is ten years.

NOW THEREFORE the Mun sipal Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY LOCAL IMPROVE-MENT CONSTRUCTION BY-LAW NO. 3, 1958".
- 2. Asphalt pavements 20 feet wide shall be constructed on the streets more particularly described in Schedule "A" annexed hereto as a local improvement under the provisions of Part XVI of the Municipal Act.
- 3. The Engineer of the Corporation shall forthwith make such plans, profiles, and specifications and furnish such information as may be necessary for the making of a contract for the execution of the work.
- 4. The work shall be carried on and executed under the superintendence and according to the directions and orders of such Engineer.
- 5. The Reeve and Clerk are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to the approval of this Council to be declared by resolution.
- 6. The Treasurer may (subject to the approval of the Council) agree with any bank or person for temporary advances of money to meet the cost of the work pending the completion of it.
- 7. (1) When the number of feet of a parcel of land which abuts on any of the said works is more than 66 feet, the taxable foot frontage shall be 66 feet.
- (2) Notwithstanding anything in this section contained, the actual foot frontage of those parcels of land on Merritt Avenue, from Beresford Street to Imperial Street, shall be the taxable foot frontage.
- (3) Notwithstanding anything in this section contained, the actual foot frontage of the following described parcels shall be the taxable foot frontage:

- (a) Lot 19, Block 9, District Lot 122, Group 1, New Westminster District, Plan 1308, except the north 20 feet.
- (b) Lot 1, Block 10, District Lot 122, Group 1, New Westminster District, Plan 1308, except the north 20 feet.
- (c) Lot "B", Block 2 west part, District Lots 151 and 153, Group 1, New Westminster District, Plan 15880.
- (d) Lot 1, Block 1, District Lots 151 and 153, Group 1, New Westminster District, Plan 1662.
- (e) Lot 19, Block 6, District Lot 122, Group 1, New Westminster District, Plan 1308.
- 8. The Assessor shall forthwith prepare a frontage-tax assessment roll in respect of the said works pursuant to section 416 of the Municipal Act and shall from time to time revise the said frontage-tax assessment roll in accordance with subsection (3) of the said section 416.
- 9. The frontage-tax to be levied against the lands abutting on the said works shall be paid by ten annual instalments.
- 10. The debentures to be issued for the loan to be effected to pay for the cost of the work when completed shall bear interest at such rate per annum as the Council may determine in the By-law providing for the issue of the said debentures, and be made payable within ten (10) years on the serial plan.
