BY-LAW NO. 4022

A BY-LAW to amend By-law No. 1991 being the  
"Burnaby Town Planning By-law 1948."

WHEREAS applications for rezoning have been made  
to the Municipal Council.

AND WHEREAS the Municipal Council has held a public  
hearing thereon after duly giving notice of the time and  
place of such hearing.

NOW THEREFORE the Municipal Council of The Corpora-  
tion of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TOWN PLANNING  
BY-LAW 1948, AMENDMENT BY-LAW NO. 1, 1959."

2. Section (1) of Schedule 1 is amended by deleting  
therefrom the following:

"East half of Lot "D", Subdivision 1, Block 1,  
District Lot 25 West, Group 1, New Westminster District,  
Plan 19669; East half of Lots "A" and "D", Subdivision 2,  
Block 1, District Lot 25 West, Group 1, New Westminster  
District, Plan 19669; West half of Lot "D", Subdivision 1,  
Block 1, District Lot 25 West, Group 1, New Westminster  
District, Plan 19669; and West half of Lots "A" and "D",  
Subdivision 2, Block 1, District Lot 25 West, Group 1, New  
Westminster District, Plan 19669."

3. Section (2) of Schedule 1 is amended by deleting  
therefrom the following:

"Lots "A" and "B", Subdivisions 1 and 2, Block 6,  
District Lot 28 Central, Group 1, New Westminster District,  
Plan 14865.

Lots 21 and 22, Block 6, District Lot 28 Central,  
Group 1, New Westminster District, Map 627."

4. Schedule 2 is amended by deleting therefrom the following:

"Lots 11, 12, 13 and 14, Subdivision 4, Block 7, District Lot 6, Group 1, New Westminster District, Plan 18504."

5. Section 4 of Schedule 1 of By-law No. 1991 is amended by adding the following as clauses (i); and (j).

"(i) West half of Lot "D", Subdivision 1, Block 1, District Lot 25 West, Group 1, New Westminster District, Plan 19669.

(j) West half of Lots "A" and "D", Subdivision 2, Block 1, District Lot 25 West, Group 1, New Westminster District, Plan 19669."

6. Section 5 of Schedule 1 of By-law No. 1991 is amended by adding thereto the following:

"(g) Lots 11, 12, 13 and 14, Subdivision 4, Block 7, District Lot 6, Group 1, New Westminster District, Plan 18504.

(h) Lots "A" and "B", Subdivisions 1 and 2, Block 6, District Lot 28 Central, Group 1, New Westminster District, Plan 14865.

(i) Lots 21 and 22, Block 6, District Lot 28 Central, Group 1, New Westminster District, Map 627.

(j) East half of Lot "D", Subdivision 1, Block 1, District Lot 25 West, Group 1, New Westminster District, Plan 19669.

(k) East half of Lots "A" and "D", Subdivision 2, Block 1, District Lot 25 West, Group 1, New Westminster District, Plan 19669."
